

## **January 2022 to May 2022**





## **January 2021 to May 2022**




## **Market Share by Operator**

### January 2022 to May 2022













Two, Five Years and Lifetime




# **Monthly Breakdown**



# Diversity, Equity, and Inclusion Tracking – Company Data




