



**DIRECTOR'S ORDER NUMBER ONE HUNDRED TWELVE (2023)**

**VIRGINIA LOTTERY'S "BONUS HOLIDAY CASH" RETAIL PLAYER PROMOTION FINAL RULES FOR OPERATION.**

The Virginia Lottery's "**Bonus Holiday Cash Retail Player Promotion Rules**" are promulgated in accordance with §§2.2-4002B(15) and 58.1-4006A of the *Code of Virginia* to increase awareness and sales for the three (3) **Holiday Cash** Scratch Games. The Promotion opens on December 5, 2023, contains five (5) Entry Periods, five (5) Prize Drawings, and closes on January 7, 2024, with the Promotion's final Prize Drawing on or about January 9, 2024. These rules amplify and conform to the duly adopted Virginia Lottery regulations for the conduct of Lottery games.

This Director's Order becomes effective on December 5, 2023, and shall remain in full force and effect through the end Promotion date unless amended or rescinded by further Director's Order.

## VIRGINIA LOTTERY'S BONUS HOLIDAY CASH RETAIL PLAYER PROMOTION OFFICIAL RULES

- A. PURPOSE:** A Promotion will be conducted to introduce Players to and encourage trial of the three (3) **Holiday Cash** Scratch Games while also engaging Players with eXTRA Chances, the Lottery's current flagship Scratcher 2<sup>nd</sup> Chance program. With this Promotion, five (5) Prize Drawings will be conducted to award Prize Coupons valued at fifty dollars (\$50) and redeemable at retail for Lottery products.
- B. PROMOTION PERIOD:** This Promotion will run from December 5, 2023, through January 7, 2024 ("Promotion Period"), with the final Prize Drawing on or about January 9, 2024.
- C. DEFINITIONS** (for purposes of this Promotion):

"Account" means the Virginia Lottery account through which a Player's age and identity verification takes place.

"Claimant" means a verified Entrant, Participant, or Player who presents an Entry that the Entrant presumes to be a Winning Entry.

"Coupon" means a digital coupon, containing a unique bar code, that can be printed and redeemed, prior to the coupon's expiration date, at retail for the value and product stated thereon.

"Director" means the Executive Director of the Virginia Lottery as established in Chapter 40 of Title 58.1 (§58.1-4000 *et seq.*) of the *Code of Virginia* or any other employee(s) to whom the Executive Director's authority is lawfully delegated.

"Drawing" means a formal process of randomly selecting Entries in accordance with the Promotion Rules.

"Entrant," "Participant," or "Player" means a Person who is at least eighteen (18) years of age, who makes a qualifying purchase or otherwise validly enters a Promotion in according to the approved Entry method(s) stated in the Promotion Rules in the hope of winning a Prize.

"Entry" or "Entry Form" means a method, whether electronic or paper-based, by which a Player enters a Drawing or Promotion.

"Entry Period(s)" means the time frame(s) during which Entries for this Promotion will be accepted.

"eXTRA Chances Web Code" means a series of numbers and letters that, when submitted according to any of the applicable Entry methods described herein, and when used in conjunction with all other required entry data, enters a Player into the eXTRA Chances Promotion.

"Lottery" means the Virginia Lottery.

"Lottery Board" means the group of seven (7) people, appointed by the Governor of Virginia, with the power

to adopt regulations governing the establishment and operation of the Virginia Lottery and to perform other functions that are set out in the *Code of Virginia*.

“Lottery Retailer,” “Lottery Sales Retailer,” or “Retailer” means a Person licensed by the Virginia Lottery to sell and dispense Virginia Lottery Tickets, materials, and products.

“Mobile Application” or “Mobile App” means a software application developed specifically for use on small, wireless computing devices, such as smartphones and tablets, rather than desktop or laptop computers, via which certain Promotion Entries may be submitted.

“Person” means a natural person and may not extend to or be applied to a corporation, company, partnership, association or other entity, or when referring to a Lottery retailer, the term as defined in § 58.1-4009 of the Code of Virginia.

“Prize” or “Prizes” means the winnings as defined in the **Section J** (“Prize Description”) section.

“Prizewinner” means a verified Person who is entitled, via Entry verification, to receive a Prize under the rules of a Promotion.

“Promotion” means the “added value” offer to consumers named in the title at the top of Page 1 of these Rules.

“Promotion Entry Number” means the 14-digit number printed on the back of an eligible Scratcher that, when submitted according to any of the applicable participation methods described herein, and, when used in conjunction with all other required Entry data, enters a Player into a Promotion.

“Promotion Rules” or “Rules” means these rules.

“Scratcher” means a ticket with a coating over the Play Areas that, when scratched off, reveals instant game play results.

“Scratch Game” means a game, played via Scratcher, which contains the appropriate Play Areas, Legend(s), Barcodes and other codes that, when played, reveals or informs a Player immediately whether the Player has won a Prize as specified in the Game Rules.

“Scratcher/Ticket” means a Scratcher or Ticket, purchased at a licensed Virginia Lottery retailer location or directly from the Virginia Lottery.

“Self-service Vending Machine” or “Vending Machine” means an interactive device by which a Player may select a game, purchase a Ticket, and/or receive a Promotion Entry Form, without the help of a clerk at a Virginia Lottery Retailer or an employee at a Virginia Lottery office or other approved location.

“System Day” means the time at which a particular day begins in the Lottery’s gaming system (4:30 AM Eastern Time) to the time the same day ends in the Lottery’s gaming system (1:00 AM Eastern Time the following calendar day).

“Terminal” means a device that is authorized by the Virginia Lottery to interact with the Virginia Lottery’s central computer system to issue Virginia Lottery Tickets and/or Entry Forms and to enter, receive and process Virginia Lottery transactions that may include issuing Tickets, validating Tickets and transmitting reports.

“Ticket” means a Ticket produced by the Virginia Lottery’s gaming system and sold by the Virginia Lottery.

"Web Code" means the 6-digit code printed on the front of a Non-winning Scratcher that, when submitted according to any of the applicable participation methods described herein, and when used in conjunction with all other required Entry data, enters a Player into a Promotion.

"Winning Entry" means an eligible Promotion Entry, drawn during the established Drawing(s), that has passed all Lottery validation and security requirements and processes.

**D. ELIGIBILITY:**

1. This Promotion is open to Players eighteen (18) years of age or older. A Player will be required to provide proof of the Player's date of birth.
2. Persons who are in the Voluntary Exclusion Program, pursuant to §58.1-4015.1 of the *Code of Virginia*, are ineligible to participate in any Lottery promotions.
3. No officer, employee or Board member of the Lottery, or any officer or employee or board member of any vendor to the Lottery of Computer-generated or Scratch Game goods or services working directly on a contract with the Lottery for such goods or services, or any person residing in the same household of any such Board member, officer or employee, or any person under the age of eighteen (18) years, shall be eligible to participate in this Promotion. The Lottery will not award a Prize on an Entry submitted by, for, or gifted to or transferred to anyone referenced under this **Section D**, or to the transferee of such Person.

**E. PROMOTION ENTRY:** To participate, a Player must purchase one of the three (3) Virginia Lottery **Holiday Cash** Scratch Games during an Entry Period specified in **Section I** ("Entry Deadlines"). Both winning and nonwinning Scratcher Tickets from the three (3) **Holiday Cash** Scratch Games will be accepted as Entries for this Promotion. Entries for this Promotion will be accepted via the Promotion's landing page on the Lottery's website and the Lottery's mobile app.

Players entering an eligible **nonwinning Holiday Cash** Scratcher will also be eligible to use their Scratcher as an Entry into the Virginia Lottery's *eXTRA Chances Promotion*. Although both winning and nonwinning **Holiday Cash** Scratchers are eligible for entry into this Promotion, only **nonwinning Holiday Cash** Scratchers are eligible for entry into the *eXTRA Chances Promotion*. The nonwinning tickets must be entered into the *eXTRA Chances Promotion* separately. Entering the Scratcher into the *Bonus Holiday Cash Promotion* does not automatically enter the ticket into the *eXTRA Chances Promotion*.

Entries for both the *Bonus Holiday Cash Retail Player Promotion* and the *eXTRA Chances Promotions* are eligible for one (1) Prize Drawing per Promotion and will not carry over to subsequent Prize Drawings. Players are eligible to win a Prize in each Promotion subject to compliance with Scratcher Ticket Entry requirements as specified above.

All Entries submitted according to **Section G** ("Website Entries"), **Section H** ("Mobile App Entries"), and received during the Promotion Entry Periods as specified in **Section I** ("Entry Deadlines"), will be included in the applicable Prize Drawings established for this Promotion.

Entries for this Promotion will only be eligible for one (1) applicable Promotion Prize Drawing. The entries do not carry over to subsequent Prize Drawings. Each Entry must contain unique entry information that will be necessary to enter this Promotion. Unique entry information can only be used once to enter this Promotion.

The Lottery, at its sole discretion, reserves the right to add or remove eligible Scratch Games to/from this Promotion. The Lottery also reserves the right to award Players with Entries into *this* Promotion as Prizes in other authorized Promotions being offered concurrently.

## F. ENTRY REQUIREMENTS:

1. Each eligible **Holiday Cash** Scratcher used for Entry into this Promotion must have been issued by the Lottery in an authorized manner and entered during an Entry Period referenced in **Section I** ("Entry Deadlines").
2. Only Virginia Lottery **Holiday Cash** Scratchers from the following Scratch Games will be eligible for entry in this Promotion.

**Game #2251 - \$1 Holiday Cash 5X**  
**Game #2252 - \$2 Holiday Cash 10X**  
**Game #2253 - \$5 Holiday Cash 20X**

3. A Player may submit, to *this* Promotion, a maximum of twenty-five (25) eligible **Holiday Cash** Scratchers per day over the course of the Promotion. This requirement does not limit a Player from entering eligible Scratchers into other Lottery Promotions being offered simultaneously.
4. With this Promotion, Players will receive a number of Entries equal to **DOUBLE** the price point of the Scratcher for the current Prize Drawing in this Promotion, in the *First Half FY2024 eXTRA Chances (July – December 2023) Promotion* and/or the *January 2024 eXTRA Chance Promotion* based upon the Entry date. Double Entries issued for eligible Scratchers submitted into the *eXTRA Chances Promotion* will only be issued during the Promotion Period for this Promotion as stated in **Section B** ("Promotion Period").

**Example: One \$5 Holiday Cash 20X Scratcher would generate ten (10) separate Entries for each Promotion.**

5. A Player will be eligible to win one (1) Prize per Drawing in this Promotion. Once a Prizewinner has won a Prize in a Drawing, the Prizewinner will not be eligible to win again until the next Drawing. Refer to **Section E** ("Promotion Entry"). Entries that are not selected as a Prizewinner in a Prize Drawing **do not** carry over to subsequent Prize Drawings.
6. The Lottery will not be responsible for **Holiday Cash** Scratchers submitted incorrectly or received outside of the established Entry Period(s) for the Prize Drawing(s) as specified in **Section I** ("Entry Deadlines"). Such Entries shall be deemed invalid.
7. Only **Holiday Cash** Scratchers that are submitted in the manner described in **Section G** ("Website Entries") and **Section H** ("Mobile App Entries") of these Promotion Rules during the designated Entry Periods will be eligible for Entry in this Promotion and to win a Prize. Hand-delivered Scratchers and Scratchers submitted via any other method not specified in these Promotion Rules will not be accepted as an Entry for this Promotion and will be deemed invalid.
8. Each Entry submitted for this Promotion must contain the Entrant's current and valid information in order to be eligible to win a Prize in this Promotion. The Lottery will not change or update information for an Entry that has already been submitted. This includes address and telephone number updates. The Lottery will not be responsible for numbers that are transposed or for information that is entered incorrectly. The Lottery will not be responsible for data-entry errors by Entrants or for connectivity issues involving the Player's access to the Virginia Lottery's Website or Mobile App.
9. Each applicable Scratcher used as an Entry for this Promotion must have been issued by the Lottery in an authorized manner during the Entry Period(s) referenced in these Rules, must be intact and must not be mutilated, altered, reconstituted or tampered with in any manner.

10. A Prizewinner's *Winner Notification Letter* will be mailed to the address registered with the Winner's Player Account at the time of the Entry submission. Any Prizewinner whose *Winner Notification Letter* is returned undeliverable due to blocked e-mails, incorrect/incomplete address information, or expired forwarding address notifications and/or delivery delays due to mail forwarding notifications, and who fails to notify the Lottery before the claim deadline date regarding the incorrect address, will forfeit the opportunity to win a Prize in this Promotion. Neither the Lottery nor its designee will be required to attempt delivery of a *Winner Notification Letter* more than once unless the Prizewinner notifies the Lottery **before the claim deadline date** regarding the incorrect address. If the Lottery is notified prior to the claim deadline date, the Lottery will email the required form(s) to the Prizewinner using the email address provided at the time of Entry submission.

#### G. WEBSITE ENTRIES:

1. To enter via the Website, a Player must go to the Lottery's Promotion page for this Promotion at <http://www.valottery.com/holidaycash> and successfully complete registration\* or login if already registered.

*\*Registration will require entry of a Player's correct full name [consisting of the Player's first name and last name (no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of the Player's Social Security number, and telephone number.*

2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be provided.
3. A Player entering via the Internet can use a computer, a mobile device and/or mobile telephone to access the Lottery's Website. When using a mobile device, a Player can choose to enter their Promotion Entry Number and Web Code manually or by using their mobile device's camera to scan the Ticket Number barcode listed on the front of their eligible Scratcher.
4. A Player who chooses to manually enter the Promotion Entry Number must correctly enter **BOTH** the Promotion Entry Number found on the back of each eligible **Holiday Cash** Scratcher and the Web Code found on the front of each eligible **Holiday Cash** Scratcher. The Lottery will not be responsible for Promotion Entry Numbers and/or Web Codes that are transposed or entered incorrectly. If the submitted numbers cannot be verified, the Entry will be deemed invalid and not eligible for entry into this Promotion.
5. Once a Player has successfully entered the Player's **Holiday Cash** Scratcher information via the Lottery's Website, the Player **does not** need to retain the Scratcher in order to claim a Prize in this Promotion. If the Scratcher is nonwinning and the Player also enters it separately into the *eXTRA Chances Promotion*, the Player does not need to retain the Scratcher in order to claim a prize in an *eXTRA Chances Prize Drawing*.

**H. MOBILE APP ENTRIES:**

1. To enter via the Lottery's Mobile App, a Player must have the app downloaded on the Player's mobile device and then go to the Promotions tab and select the Bonus **Holiday Cash** Promotion where the Player must tap on the "Scan To Enter" button and successfully complete registration\* or login if already registered.

\*Registration will require entry of a Player's correct full name (consisting of the Player's first name and last name – no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of the Player's Social Security Number and telephone number.

2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be necessary.
3. Players must correctly scan and enter their **Holiday Cash** Scratcher Promotion Entry Number and Web Code to enter this Promotion. Entries whose Scratcher Promotion Entry Number and/or Web Code cannot be verified will be deemed invalid and not eligible for entry into this Promotion.
4. Once a Player has successfully entered the Player's **Holiday Cash** Scratcher information via the Lottery's Mobile App, the Player **does not** need to the Scratcher in order to claim a Prize in this Promotion. If the Scratcher is nonwinning and the Player also enters it separately into the *eXTRA Chances Promotion*, the Player does not need to retain the Scratcher in order to claim a prize in an eXTRA Chances Prize Drawing.

The Lottery reserves the right to replace any prize with a prize of comparable value.

**K. PROMOTION DRAWINGS:** The following are the five (5) established Prize Drawing dates for this Promotion:

Drawings will be conducted from all eligible Entries submitted via the established Entry methods and by the established Entry Deadline date. The following is an overview of how the Entries will be randomly selected for this Promotion.

1. After the established Entry deadline date, but prior to the Drawing, all eligible Entries submitted for that Drawing will be accounted for and the information loaded into a randomizer program.
2. Representatives from the Lottery's Security, Audit, Information Technology Services, and Marketing departments will oversee the use of the randomizer program selecting the Winning Entries for this Promotion.
3. Twenty-five (25) Prizewinners will be randomly selected for each Prize Drawing. The order in which the Winning Entries are drawn shall be recorded by Lottery officials. The Lottery's decision shall be final and controlling.

4. Immediately after the Prizewinners are selected, ten (10) alternate Entries will also be selected using the same randomizer program. All alternate Prizewinners will be recorded in the order in which they were selected and will be used at the Lottery's discretion should a Prizewinner be determined ineligible.
5. After the Drawing is completed, representatives of the Lottery's Security, Audit, Information Technology Services, and Marketing departments will confirm that the Entries selected in the Drawing are valid.
6. In the event a selected Entry is deemed invalid (see **Section F** "Entry Requirements"), the first alternate with a valid Entry will be selected as a Prizewinner. This process shall continue until all valid Winning Entries have been selected for the particular Prize Drawing.

#### **L. PRIZEWINNER PROCEDURES:**

Each Promotion Prizewinner selected in association with this Promotion will be notified by the Lottery via the United States Postal Service (USPS) and email. All Prizewinners will receive a *Prizewinner Claim Form*. The Prizewinner will be required to complete and return the completed *Prizewinner Claim Form* by the deadline stated in their *Winner Notification Letter*. Any Prizewinner who fails to fully complete and return the required *Prizewinner Claim Form* documentation containing the Prizewinner's full Social Security number by the date noted in their *Winner Notification Letter* will forfeit the Prize.

#### **M. PRIZEWINNER VERIFICATION:**

1. Methods used by the Lottery to establish and confirm a Prizewinner's identity include, but are not limited to:
  - viewing and/or copying the Prizewinner's valid government-issued photo identification;
  - viewing and/or copying proof of taxpayer identification number (e.g., Social Security number);
  - asking identity-verifying questions in the absence of the aforementioned document proof; and/or
  - viewing and/or retaining the information provided on a Lottery *Prizewinner Claim Form*.
2. **In all cases involving a Prize greater than \$100**, the Lottery must be provided with a copy of the Prizewinner's valid government-issued photo identification and taxpayer identification number (e.g., Social Security number). Payment will be delayed until such a number is provided, and the Prizewinner shall not be entitled to interest on the Prize funds attributable to such delay.

#### **N. PRIZE AWARD/PAYMENT**

1. When paying any Prize **in excess of \$600**, the Lottery shall report the winnings or withhold taxes pursuant to rules established by the Internal Revenue Service and Virginia Department of Taxation and shall file the appropriate income reporting form(s) with the Internal Revenue Service and the Virginia Department of Taxation. Additionally, if the Prize is a cash Prize **greater than \$100** and subject to any set-off for delinquent debts, the Lottery shall withhold any monies due under the Commonwealth's Set-Off Debt Collection Act if the agency has registered such debt with the Virginia Department of Taxation and timely notice of the debt has been furnished by the Virginia Department of Taxation to the Lottery.
2. Lottery Prizes awarded during this Promotion are not transferable or assignable. A Person shall not enter the Promotion on behalf of another Person. Such Entries shall be deemed invalid. The Virginia Lottery Coupon Prize awarded during this Promotion **is not** redeemable for cash.

3. Each Prizewinner who wins a Prize **greater than \$600** is legally required to include the value of the Prize, as well as any taxes paid by the Lottery on the Prizewinner's behalf, in the Prizewinner's taxable income for tax reporting purposes. As a result of accepting a Prize and taking into account a Prizewinner's total taxable income for the year in which the Prize is accepted, a Prizewinner may fall into a higher tax bracket for federal and state tax liabilities for the year in which the Prize is accepted.
4. A Prizewinner agrees to participate in a press conference and agrees to the use of the Prizewinner's name and/or photo for publicity at the Lottery's discretion. Examples of publicity include, but are not limited to, news releases, Internet, news media and signs at Lottery Retailer locations. In addition, a Prizewinner agrees to participate in Lottery promotional efforts which may include the Prizewinner's name, hometown, the amount of the Prize won, and the Promotion won, through "social media," which may include, but will not be limited to, YouTube®, Twitter®, Facebook®, Instagram® or similar efforts, without additional consent from or compensation to the Prizewinner.

**O. CANCELLATION POLICY:**

Canceled Drawing(s) or Prize Award(s): The Director may, in the Director's sole discretion, cancel Prize Drawings and/or the awarding of Prizes, on holidays, days of special importance or on days when conditions make conducting the Drawings or awarding Prizes impractical or inappropriate, and may elect to conduct Drawings and/or make-up Drawings and/or the awarding of Prizes at such times and dates, and pursuant to such methods, as the Director may determine, all with the Director's sole discretion.
