

DIRECTOR'S ORDER NUMBER ONE HUNDRED THIRTEEN (2024)

CERTAIN VIRGINIA LOTTERY PROMOTION; CHANGE TO ENTRY REQUIREMENTS

In accordance with the authority granted by §§ 2.2-4002B (15) and 58.1-4006A of the Code of Virginia, I hereby give notice that the following Virginia Lottery Promotion:

"\$5K Giveaway Retail Player Promotion Rules" (108 2024)

is amended as follows:

in Section E. PROMOTION ENTRY:

From:

To participate, a Player must purchase Virginia Lottery Pick 3, Pick 4, and Pick 5 Daily Game Tickets during the Promotion Period and enter the eligible tickets/plays via the established entry methods for this Promotion's Prize Drawing. Tickets/Plays eligible for entry into this Promotion can be either winning or nonwinning Tickets/Plays. Entries for the Prize Drawing will be accepted via a Player's Account accessed from either the Lottery's Mobile App or the mobile version of the Lottery's website.

All Entries submitted according to Section G ("Mobile Website Entries"), Section H ("Mobile App Entries") and Section I ("Online Purchase Entries") and received during the Promotion Entry Period as specified in Section J ("Entry Deadline") will be included in the Prize Drawing.

A Player may enter the Promotion more than once as long as each Entry is based upon the purchase of eligible games. An eligible Entry is defined as an Entry containing a Pick 3, Pick 4, and Pick 5 Game Ticket/Play purchased online and/or in a retail location during the Promotion Period.

A Player is eligible to win only one (1) Prize in the Prize Drawing.

The Lottery, at its sole discretion, reserves the right to award Players with Entries into this Promotion as Prizes in other authorized Promotions being offered concurrently.

From:

Only Pick 3, Pick 4, and Pick 5 Daily Game Tickets/Plays issued in conjunction with/purchased at a Lottery retailer location or online directly from the Virginia Lottery will be accepted to be eligible as valid Entries for this Promotion. The Tickets/Plays must be purchased during the Promotion Period, and consist of Pick 3, Pick 4, and Pick 5 games, to be eligible for entry.
- 6. Each Pick 3, Pick 4, and Pick 5 Game Ticket/Play entered to qualify for an Entry into this Promotion must have been issued by the Lottery in an authorized manner during the Promotion Period and submitted during the Entry Period referenced in Section J ("Entry Deadline").

To:

- 1. Only Pick 3, Pick 4, and Pick 5 Daily Game Tickets/Plays issued in conjunction with/purchased at a Lottery retailer location or online directly from the Virginia Lottery will be accepted to be eligible as valid Entries for this Promotion. The Tickets/Plays must be purchased before 11:59 pm (ET) on October 6, 2024 and consist of Pick 3, Pick 4, and Pick 5 games, to be eligible for entry.
- 6. Each Pick 3, Pick 4, and Pick 5 Game Ticket/Play entered to qualify for an Entry into this Promotion must have been issued by the Lottery in an authorized manner before 11:59 PM (ET) on October 6, 2024, and submitted during the Entry Period referenced in Section J ("Entry Deadline").

With the exception of the foregoing changes, all terms, conditions, and requirements of the original order and the original promotion rules continue to apply and remain in full force and effect.
