

DIRECTOR'S ORDER ONE-HUNDRED TWENTY-EIGHT (2025)

VIRGINIA LOTTERY'S "DON'T THROW AWAY FREE PLAY PROMOTION" RETAIL PLAYER PROMOTION FINAL RULES FOR OPERATION.

The Virginia Lottery's "Don't Throw Away Free Play Promotion Rules" are promulgated in accordance with §§2.2-4002B(15) and 58.1-4006A of the Code of Virginia. The Don't Throw Away Free Play Promotion opens on September 1, 2025, contains one (1) Entry Period, one (1) Prize Drawing, and closes on October 31, 2025, with the Promotion's Prize Drawing on or about November 4, 2025. These rules amplify and conform to the duly adopted Virginia Lottery regulations for the conduct of Lottery games.

This Director's Order becomes effective on September 1, 2025, and shall remain in full force and effect through the end Promotion date unless amended or rescinded by further Director's Order.

VIRGINIA LOTTERY'S DON'T THROW AWAY FREE PLAY PROMOTION OFFICIAL RULES

- A. GENERAL REQUIREMENTS: In addition to these Rules, all requirements in the language on www.valottery.com, the Virginia Lottery laws and regulations, the Virginia Lottery Rewards Program Overview and Requirements apply to this promotion. This Promotion is tied to the Virginia Lottery Loyalty Rewards Program and allows participants who purchase Lottery products from a retail location and scan them to their Rewards Player Account, to automatically be entered into a Prize Drawing. With this Promotion, one (1) Prize Drawing will be conducted to award ten (10) Powerball subscriptions.
- **B. PROMOTION PERIOD:** The **Don't Throw Away Free Play Promotion** will run from September 1, 2025, through October 31, 2025 ("Promotion Period"), with the Prize Drawing on or about November 4, 2025.
- C. **DEFINITIONS** (for purposes of this Promotion):
 - "Account" means the Virginia Lottery account through which a Player's age and identity verification takes place.
 - "Cash Prize" means cash, check, or generic debit card.
 - "Claimant" means a verified Entrant, Participant, or Player who presents an Entry that the Entrant presumes to be a Winning Entry.
 - "Director" means the Executive Director of the Virginia Lottery as established in Chapter 40 of Title 58.1 (§58.1- 4000 et seq.) of the Code of Virginia or any other employee(s) to whom the Executive Director's authority is lawfully delegated.
 - "Drawing" means a formal process of randomly selecting Entries in accordance with the Promotion Rules.
 - "Entrant," "Participant," or "Player" means a Person who is at least eighteen (18) years of age, who makes a qualifying purchase or otherwise validly enters a Promotion in according to the approved Entry method(s) stated in the Promotion Rules in the hope of winning a Prize.
 - "Entry" means a method, whether electronic or paper-based, by which a Player enters a Drawing or Promotion.
 - "Entry" or "Entry Form" means a method, whether electronic or paper-based, by which a Player enters a Drawing or Promotion.
 - "Entry Period(s)" means the time frame(s) during which Entries for this Promotion will be accepted.
 - "Lottery" means the Virginia Lottery.

"Lottery Board" means the group of seven (7) people, appointed by the Governor of Virginia, with the power to adopt regulations governing the establishment and operation of the Virginia Lottery and to perform other functions that are set out in the Code of Virginia.

"Lottery Retailer," "Lottery Sales Retailer," or "Retailer" means a Person licensed by the Virginia Lottery to sell and dispense Virginia Lottery Tickets, materials, and products.

"Mobile Application" or "Mobile App" means a software application developed specifically for use on small, wireless computing devices, such as smartphones and tablets, rather than desktop or laptop computers, via which certain Promotion Entries may be submitted.

"Non-cash Prize" means merchandise, a trip, a store-specific gift card, etc., that is not immediately convertible to cash. Commonwealth Set-Off Debt Collection Act requirements do not pertain to Non-cash Prizes.

"Person" means a natural person and may not extend to or be applied to a corporation, company, partnership, association or other entity, or when referring to a Lottery retailer, the term as defined in § 58.1-4009 of the Code of Virginia.

"Play" refers to one (1) wager.

"Prize" or "Prizes" means the winnings as defined in **Section J** ("Prize Descriptions") section.

"Prizewinner" means a verified Person who is entitled, via Entry verification, to receive a Prize under the rules of a Promotion.

"Promotion" means the "added value" offer to consumers named in the title at the top of Page 1 of these Rules.

"Promotion Rules" or "Rules" means these rules.

"Rewards Program" means the <u>Virginia Lottery Rewards Program</u> which provides Players with the opportunity to earn points for purchasing Lottery products and/or participating in non-spend activities and redeem points for free Lottery play and/or drawing entries, where persons who qualify must register for a Lottery Account to participate.

"Scratcher" means a ticket with a coating over the Play Areas that, when scratched off, reveals instant game play results.

"Scratch Game" means a game, played via a Scratcher, that contains the appropriate Play Areas, Legend(s), Barcodes and other codes that, when played, reveals or informs a Player immediately whether the Player has won a Prize as specified in the Game Rules.

"Self-Service Vending Machine" or "Vending Machine" means an interactive device by which a Player may select a game, purchase a Ticket, and/or receive a Promotion Entry Form, without the help of a clerk at a Virginia Lottery Retailer or an employee at a Virginia Lottery office or other approved location.

"System Day" means the time at which a particular day begins in the Lottery's gaming system (4:30 AM Eastern Time) to the time the same day ends in the Lottery's gaming system (1:00 AM Eastern Time the following calendar day).

"Terminal" means a device that is authorized by the Virginia Lottery to interact with the Virginia Lottery's central computer system to issue Virginia Lottery Tickets and/or Entry Forms and to enter, receive, and process Virginia Lottery transactions that may include issuing Tickets, validating Tickets, and transmitting reports.

"Ticket" means a Ticket produced by the Virginia Lottery's gaming system and sold by the Virginia Lottery.

"Website" refers to the mobile version of the Virginia Lottery's Website, <u>www.valottery.com</u>, and all associated sub-sites/pages.

"Winning Entry" means an eligible Promotion Entry, drawn during the established Drawing(s), that has passed all Lottery validation and security requirements and processes.

D. ELIGIBILITY:

- 1. This Promotion is open to Players eighteen (18) years of age* or older. A Player will be required to provide proof of the Player's date of birth.
- 2. Persons who are in the Voluntary Exclusion Program, pursuant to §58.1-4015.1 of the Code of Virginia, are ineligible to participate in any Lottery promotions.
- 3. No officer, employee or Board member of the Lottery, or any officer or employee or board member of any vendor to the Lottery of Computer-generated or Scratch Game goods or services working directly on a contract with the Lottery for such goods or services, or any person residing in the same household of any such Board member, officer or employee, or any person under the age of eighteen (18) years, shall be eligible to participate in this Promotion. The Lottery will not award a Prize on an Entry submitted by, for, or gifted to or transferred to anyone referenced under this Section D, or to the transferee of such Person.
- **E. PROMOTION ENTRY:** To participate in this Promotion, a Player must scan eligible* Scratchers and/or Terminal Generated Game Tickets into their Virginia Lottery Rewards Account that were purchased at a Lottery retail location during the Promotion Period ("eligible Tickets"). Eligible Tickets purchased and scanned into a Player's Rewards Account will automatically be entered into the Prize Drawing for this Promotion. All Lottery retail purchased Tickets can be scanned into a Player's Rewards Account via the Virginia Lottery's Mobile Website and the Virginia Lottery's Mobile App.

*Eligible Scratchers are winning or non-winning \$1, \$2, \$5, \$10, \$20, \$30 and \$50 Scratchers that are available for purchase and/or are still in the claim eligibility period (180 days after official game close date).

All eligible Tickets submitted in accordance with these Rules, the <u>Virginia Lottery Rewards Program Overview</u> and <u>Requirements</u> and received during the Entry Period as stated in **Section I** of these Rules will automatically be included in the applicable Prize Drawing.

A Player wishing to enter a winning Ticket into this Promotion must do so **prior** to cashing their Ticket. All eligible Tickets submitted according to **Section G** ("Mobile Website Entries") and **Section H** ("Mobile App Entries") **and** received during the designated Promotion Entry Period as specified in **Section I** ("Entry Deadline") **will automatically be included** in the Prize Drawing for this Promotion.

A Player may enter the Promotion more than once as long as each Entry is based upon a different eligible Lottery Ticket and the total number of Entries does not exceed the fifty (50) daily maximum.

Qualifying purchases made during the Promotion Period for this Promotion are also eligible for submission in the Virginia Lottery's Rewards Program.

The Lottery, at its sole discretion, reserves the right to add or remove eligible Scratchers and Terminal Generated Games to/from this Promotion. The Lottery also reserves the right to award Players Entries into this Promotion as Prizes in other authorized Promotions being offered concurrently.

F. ENTRY REQUIREMENTS:

- 1. Each eligible Ticket used as an Entry into this Promotion must have been issued by the Lottery in an authorized manner during the Entry Period referenced in **Section I** ("Entry Deadline") of these rules.
- 2. A Player may submit, to this Promotion, a maximum of fifty (50) Tickets per day over the course of the Promotion. This requirement does not limit a Player from entering into other Lottery Promotions being offered simultaneously.
- 3. A Player is eligible to win one (1) Prize in this Promotion's Prize Drawing. Once a Prizewinner has won a Prize in a Prize Drawing, the Prizewinner will not be eligible to win again.
- 4. The Lottery will not be responsible for Lottery tickets submitted incorrectly or received outside of the established Entry Period for the Prize Drawing as specified in **Section I** ("Entry Deadline"). Such Entries shall be deemed invalid.
- 5. Only eligible Tickets that are submitted into the Rewards Program in the manner described in **Section E** ("Promotion Entry") of these Rules during the designated Entry Period described in **Section I** ("Entry Deadline") will be eligible for Entry into this Promotion's Prize Drawing to win a Prize.
- 6. Each Entry submitted into this Promotion will use the contact information contained in a Player's Account at the time of the Entry submission. This information must be current and valid in order to be eligible to win a Prize. The Lottery will not change or update information for an Entry that has already been submitted, including address and telephone number updates. The Lottery will not be responsible for data-entry errors by Entrants or for connectivity issues involving the Player's access to the Virginia Lottery's Website or Mobile App.
- 7. A Prizewinner's Winner Notification Letter will be mailed to the address registered with the Prizewinner's Virginia Lottery Player Account at the time of the Entry's submission. Any Prizewinner whose Winner Notification Letter is returned undeliverable due to blocked e-mails, incorrect/incomplete address information, or expired forwarding address notifications, and/or delivery delays due to mail forwarding notifications, who fails to notify the Lottery before the claim deadline date regarding the incorrect address, will forfeit the opportunity to win a Prize in this Promotion. Neither the Lottery nor its designee will be required to attempt delivery of a Winner Notification Letter more than once unless the Prizewinner notifies the Lottery before the claim deadline date regarding the incorrect address. If the Lottery is notified prior to the claim deadline date, the Lottery will email the required form to the Prizewinner using the email address provided at the time of Entry submission.

G. MOBILE WEBSITE ENTRIES:

- 1. To enter eligible Tickets via the Lottery's Mobile Website, a Player must use a mobile device to go to the Lottery's Website at **valottery.com** and successfully complete registration or login.
 - *Registration will require entry of a Player's correct full name [consisting of the Player's first name and last name (no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of the Player's Social Security number, and telephone number].
- 2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be necessary.
- 3. Players entering this Promotion via the Internet must use a mobile device to access the Lottery's mobile version of its Website and the Player's Account to enter the required Ticket information. The player must tap the scanner icon button and correctly scan the barcode of the eligible Ticket into the Player's Account to enter this Promotion.
- 4. The Lottery will not be responsible for information entered incorrectly.
- 5. Once an eligible Ticket is successfully entered via the mobile website to qualify as a Promotion Entry, it **will not be** required to be presented in order to claim a Prize in this Promotion.

H. MOBILE APP ENTRIES:

- 1. To enter via the Lottery's Mobile App, a Player must have the app downloaded on a mobile device and then press the scanner button at the top of the app after the Player has logged in or successfully complete registration*.
 - *Registration will require entry of a Player's correct full name [consisting of the Player's first name and last name (no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of the Player's Social Security Number, and telephone number].
- 2. As part of the Lottery's registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player's identity cannot be confirmed, additional steps for manual confirmation of identity will be necessary.
- 3. To submit an eligible Ticket, a player must tap the scanner icon button and correctly scan the barcode on the Ticket into the Player's Account. A Player must correctly scan and enter the Ticket Number Barcode on the Player's Ticket to enter this Promotion. Ticket information that cannot be verified will be deemed invalid and not eligible to qualify for an entry into this Promotion.
- 4. Once an eligible Ticket is successfully entered via the Lottery's Mobile App to qualify as a Promotion Entry, the Ticket **will not be** required to be presented in order to claim a Prize in this Promotion.

I. ENTRY DEADLINE:

J. PRIZE DESCRIPTIONS: The following Prizes will be awarded during this Promotion:

Should, for reasons out of the Lottery's control, the originally proposed Prize becomes unavailable, a Prizewinner will be given an alternate Prize or Prizes of equal value. The Lottery reserves the right to replace a Prize or Prizes or portions thereof with a Prize or Prizes or portions thereof of comparable value. The Lottery, at its own discretion, also reserves the right to offer the cash value of a Prize or Prizes should the proposed Prize or Prizes be cancelled or permanently unavailable.

Winners are required to sign and execute a liability release prior to Prize fulfillment for any Non-cash Prize.

K. PROMOTION DRAWINGS: The following is the established Prize Drawing date for this Promotion.

November 4, 2025

The Prize Drawing will be conducted from all eligible Entries submitted by Players and received via the established Entry methods and by the established Entry deadline date. The following is an overview of how the Entries will be randomly selected for this Promotion.

After the established Entry deadline date, but prior to the Prize Drawing, all eligible Entries submitted for this Promotion will be accounted for. The Virginia Lottery's Audit, Security, and Marketing departments will retrieve and verify the Entries. This process will involve independent confirmation of the submitted Entry information and the number of valid Entries received for that Drawing. After the submitted Entry information and number of valid Entries received have been confirmed, all valid Entries submitted and received by the established Entry deadline date will be loaded into a randomizer program.

- Representatives from the Virginia Lottery's Audit, Security, and Marketing departments will participate
 in and observe the Drawings. All Drawings will be conducted over a video conferencing platform
 and recorded. Recordings will be maintained and stored in accordance with the Library of Virginia
 retention schedules.
- 2. Prizewinners will be randomly selected. The order in which the Winning Entries are drawn shall be recorded by Lottery officials. The Lottery's decision shall be final and controlling.

- 3. Immediately after the Winning Entries are selected for the Drawing, Alternate Winning Entries will be selected using the same approved randomizer program utilizing the same process in selecting the Winning Entries. If the number of Winning Entries selected in the Drawing is less than fifty (50), ten (10) alternate Winning Entries will be selected. If the number of Winning Entries selected in the Drawing is fifty (50) or more, twenty (20) alternate Winning Entries will be selected.
- 4. After the Drawing is complete, representatives of the Virginia Lottery's Security, Audit, and Marketing departments will confirm the Winning Entries selected in the Drawing are valid and meet all Entry requirements as stated in the official Promotion Rules governing the Drawing.
- 5. In the event a selected Winning Entry is deemed invalid per the official Promotion Rules and/or procedures governing the Drawing, the first alternate Winning Entry will be selected as a Winning Entry. Any Alternate Winning Entry selected as a Winning Entry also will be required to meet all Entry requirements stated in the official Promotion Rules governing the Drawing before they are officially accepted as a Winning Entry. This process shall continue until all valid Winning Entries have been selected for the Drawing. The Virginia Lottery's decision during this process shall be final and controlling.

L. PRIZEWINNER PROCEDURES:

Each Prizewinner who has an Entry selected in the Prize Drawing with this Promotion will be notified by the Lottery via the United States Postal Service (USPS) and via the email address associated with the selected Winning Entry. All Prizewinners will receive a *Prizewinner Claim Form*. The Prizewinner will be required to complete and return the form by the deadline stated in their *Winner Notification Letter*. Any Prizewinner who fails to fully complete and return the required form along with documentation containing the Prizewinner's full Social Security number by the date noted in their *Winner Notification Letter* will forfeit the Prize.

During the Prizewinner notification process, should a Prizewinner decline the Prize being offered or fail to complete and submit any required form(s), the Prizewinner will be disqualified. At the Virginia Lottery's discretion, the available Prize may be offered to an alternate Prizewinner.

M. PRIZEWINNER VERIFICATION:

Methods used by the Lottery to establish and confirm a Prizewinner's identity include, but are not limited to:

- viewing and/or copying the Prizewinner's valid government-issued photo identification;
- viewing and/or copying proof of taxpayer identification number (e.g., Social Security number);
- asking identity-verifying questions in the absence of the aforementioned document proof; and/or
- viewing and/or retaining the information provided on a Lottery Prizewinner Claim Form.

In all cases involving a Cash Prize greater than \$100 or a Non-cash Prize greater than \$600, the Lottery must be provided with a copy of the Prizewinner's valid government-issued photo identification and taxpayer identification number (e.g. Social Security number). Payment will be delayed until such documentation is provided, and the Prizewinner shall not be entitled to interest on the Prize funds attributable to such delay.

N. PRIZE AWARD/PAYMENT

- 1. When paying any Prize **in excess of \$600**, the Lottery shall report the winnings or withhold taxes pursuant to rules established by the Internal Revenue Service and Virginia Department of Taxation
 - and shall file the appropriate income reporting form(s) with the Internal Revenue Service and the Virginia Department of Taxation. Additionally, if the Prize is a cash Prize **greater than \$100** and subject to any set-off for delinquent debts, the Lottery shall withhold any monies due under the Commonwealth's Set- Off Debt Collection Act if the agency has registered such debt with the Virginia Department of Taxation and timely notice of the debt has been furnished by the Virginia Department of Taxation to the Lottery.
- 2. All Prizes awarded during this Promotion are not transferable or assignable. A Person shall not enter this Promotion on behalf of another Person. Such Entries shall be deemed invalid. The Prizes awarded during this Promotion are not redeemable for cash or an alternate Prize unless required by law or at the Lottery's discretion due to limited circumstances. The Lottery reserves the right to replace a Prize or portions thereof with a Prize or portions thereof of comparable value.
- 3. Each Prizewinner who wins a Prize **greater than \$600** is legally required to include the value of the Prize, as well as any taxes paid by the Lottery on the Prizewinner's behalf, in the Prizewinner's taxable income for tax reporting purposes. As a result of accepting a Prize and taking into account a Prizewinner's total taxable income for the year in which the Prize is accepted, a Prizewinner may fall into a higher tax bracket for federal and state tax liabilities for the year in which the Prize is accepted.
- 4. A Prizewinner agrees to participate in a press conference and agrees to the use of the Prizewinner's name and/or photo for publicity at the Lottery's discretion. Examples of publicity include, but are not limited to, news releases, the Internet, news media and signs at Lottery Retailer locations. In addition, a Prizewinner agrees to participate in Lottery promotional efforts which may include the Prizewinner's name, hometown, the amount of the Prize won, and the Promotion won, through "social media," which may include, but will not be limited to, YouTube®, X (formerly known as Twitter®), Facebook®, Instagram® or similar efforts, without additional consent from or compensation to the Prizewinner.

O. CANCELLATION POLICY:

Canceled Drawing and/or Prize award(s): The Director may, in the Director's sole discretion cancel the Rewards Program, Rewards Program Prize Drawings, this Promotion and/or the awarding of Prizes, on holidays, days of special importance or on days when conditions make conducting the Prize Drawing and/or awarding Prizes impractical or inappropriate, and may elect to conduct Prize Drawing and/or make-up Prize Drawing and/or the awarding of Prizes at such time and date, and pursuant to such methods, as the Director may determine, all with the Director's sole discretion. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such re-schedule/cancellation.

<u>Revoked Prize award(s)</u>: The Director or the Director's designee may, in the Director's sole discretion revoke/rescind the awarding of any Prize awarded with this Promotion when a Prizewinner does not provide all required document(s). Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such revocation of a Prize.

<u>Termination of Promotion</u>: The Director may, at any time, announce a suspension or termination of this Promotion, without advance notice and in the Director's sole discretion, at which point no further Entries will be accepted and no Prizes shall be awarded. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such suspension/termination.

- **P. DISPUTES:** The Director may refrain from awarding/paying a Prize pending final determination under any of the following circumstances:
 - a. if a dispute related to any Prize occurred or if it appears that a dispute may occur;
 - b. if there is any question regarding the identity of the Claimant; or
 - c. if there is any question regarding the validity of any Entry submitted.

No liability for interest arising because of any such delay, or any delay beyond the Lottery's control, shall accrue to the benefit of the Prizewinner pending award/payment of the Prize. The Lottery is neither liable for, nor has it any responsibility to resolve, disputes between or among competing Claimants.

In the event of a dispute or other instance of doubt, the decision of the Director shall be final and binding.

- Q. GOVERNING LAW: By participating in this Promotion, each person agrees to comply with and abide by the Lottery laws, Lottery regulations, all final decisions of the Director of the Lottery, and these, and any other applicable, Rules established by the Lottery Board and/or Director of the Lottery for the conduct of this Promotion. Any dispute arising that relates to any aspect of this Promotion shall be governed by the laws of the Commonwealth of Virginia and the venue for the determination of any such dispute shall be in the city of Richmond, Virginia.
- **R. WAIVER OF CLAIMS:** By entering this Promotion, each Participant agrees to indemnify, hold harmless, and waive any claims against the Commonwealth of Virginia, the Lottery, and any of the Board Members, affiliates, employees, directors, officers, agents, representatives and assigns of any of said entities, arising, directly or indirectly, out of, or in any way connected with, this Promotion or the Prizes awarded in connection therewith.
- **S. AMERICANS WITH DISABILITIES ACT ("ADA"):** The Lottery is not responsible for any third party's compliance with ADA Rules and Regulations where applicable in connection with a Prize.
