VIRGINIA LOTTERY'S COMPUTER-GENERATED LOTTERY GAME "PICK 3" FINAL RULES FOR GAME OPERATION

The final rules for game operation in Virginia Lottery's Computer-generated Lottery Game "**Pick 3**" are promulgated in accordance with §§ 2.2-4002B(15) and 58.1-4006A of the Code of Virginia. These rules amplify and conform to the duly adopted Virginia Lottery regulations for the conduct of lottery games.

This Director's Order becomes effective upon signing, fully replaces any and all prior Virginia Lottery "**Pick 3**" Game Rules and Orders, and shall remain in full force and effect unless amended or rescinded by further Director's Order.

VIRGINIA LOTTERY'S COMPUTER-GENERATED LOTTERY GAME
"PICK 3"
OFFICIAL RULES FOR GAME OPERATION

A. GENERAL REQUIREMENTS:

1. In addition to these specific Game Rules, all requirements in the language on the back of the Ticket and the applicable requirements in the Virginia Lottery laws and regulations apply to the operation of this Game. The Virginia Lottery *Online Gaming Rules* and *Lottery Account Terms and Conditions* will also apply when purchases are made online at www.valottery.com or via the Virginia Lottery Mobile App.
2. Game Rules, Virginia Lottery laws and regulations, and terms and conditions are on file at Virginia Lottery headquarters.

B. DEFINITIONS (for the purposes of these Rules):

"50/50" means a type of Play that combines a \$.50 Exact Order Play and a \$.50 Any Order Play for a \$1.00 Play on the same **Pick 3** number. Specifically, half of the wager is placed on the number to come up in the exact same order that the number was played and half the wager is placed on the number to come up in any other order.

"50/50 (3-Way)" means a type of 50/50 Play in which a Player places a wager on a **Pick 3** number where two (2) of the three (3) digits that are identical (Example: 112)

"50/50 (6-Way)" means a type of 50/50 Play in which a Player places a wager on a **Pick 3** number where all three (3) digits are different from each other (Example: 123)

"Account" means the Virginia Lottery account through which a Player's age and identity verification takes place.

"Any Order" means a type of Play in which a Player places a wager on a **Pick 3** number to come up in any combination. A Player wins a Prize with this Play type if the **Pick 3** number drawn is any combination of the **Pick 3** number that was played. The Prize depends on the amount wagered and on the number(s) played.

"Any Order (3-Way)" means a type of Any Order Play in which a Player places a wager on a **Pick 3** number where two (2) of the three (3) digits that are identical (Example: 112).

"Any Order (6-Way)" means a type of Any Order Play in which a Player places a wager on a **Pick 3** number where all three (3) digits are different from each other (Example: 123).

"Cashing retailer" means an agency-licensed retailer that sells Lottery products and is authorized to pay prizes.

"Claimant" means a Person who presents a Ticket/online Play that the Person presumes to be a Winning Ticket/online Play or a Player with a validated Prize win from a purchased Game.

“Combo” means a type of Play in which a Player places a wager on all combinations of a **Pick 3** number.

“Combo (3-Way)” means a type of Combo Play in which a Player places a wager on all three (3) possible combinations of a **Pick 3** number where two (2) of the three (3) digits are identical (Example: 112, 121, 211).

“Combo (6-Way)” means a type of Combo Play in which a Player places a wager on all six (6) possible combinations of a **Pick 3** number where all three (3) of the digits are different (Example: 123, 132, 213, 231, 312, 321).

“Computer-generated Game” means a Virginia Lottery Game that is in direct communication with a Mainframe computer operated by or at the direction of the Virginia Lottery.

“Director” means the Executive Director of the Virginia Lottery or Director's designee.

“Drawing” means a formal process of randomly selecting numbers in accordance with the Game Rules.

“Easy Pick” means a Game feature that allows a Player to have the gaming system randomly select the Player's numbers for an individual Play. The designation “EP” is printed on a retail Ticket to denote an Easy Pick Play.

“Entitled to the Prize” means the status of a Claimant whose Ticket or online Winning Play has been validated by the Virginia Lottery as winning a Prize, unless Internal Revenue Service policy provides a different definition, in which case the Internal Revenue Service definition shall prevail.

“Exact Order” means a type of Play in which a Player places a wager on a **Pick 3** number to come up exactly as it appears on the Ticket/online Play. A Player wins a Prize with this Play type if the **Pick 3** number drawn is exactly the same as the **Pick 3** number that was played.

“FIREBALL” means the optional add-on purchase to any **Pick 3** Ticket/online Play where an additional fourth (4th) number (the “FIREBALL”) is drawn after the three (3) base **Pick 3** Game numbers are drawn. Players can use the FIREBALL number to replace one (1) of the base numbers to create one (1) or more additional number combinations. FIREBALL results and winnings are in addition to and separate from the **Pick 3** Game Play. FIREBALL cannot be played independently of the **Pick 3** Game. Refer to the Prize structure for FIREBALL Prize amounts and odds.

“Fixed Prizes” means a set amount awarded in a Game.

“Future Play” means a Game feature that allows a Player to select numbers for any one (1) future Drawing scheduled after the next most immediate Drawing up to ninety (90) days out from the current date. A Future Play can be for one (1) Drawing only. Future Play is not available with **Pick 3** online play.

“Game” means the Game named in the title at the top of Page 1 of these rules.

“Game Rules” or “Rules” means these rules.

“Lottery” means the Virginia Lottery.

“Lottery Board” means the Virginia Lottery Board established by Chapter 40 (§ 58.1-4000 et seq.) of Title 58.1 of the Code of Virginia.

"Lottery Gaming system" means any system owned, operated, or contracted by the Lottery that supports the sale, redemption, or validation of Lottery tickets or wagers.

"Lottery Retailer," "Lottery Sales Retailer," or "Retailer" means a Person or entity licensed by the Virginia Lottery to sell and dispense Virginia Lottery products.

"Mobile Application" or "Mobile App" means a software application developed specifically for use on small, wireless computing devices, such as smartphones and tablets, rather than desktop or laptop computers.

"Multi-draw Purchase" means a Game feature that allows a Player to select Plays for up to ninety-one (91) consecutive Drawings on one (1) Ticket, starting with the next scheduled Drawing. Multi-Draw Tickets/online Plays will be issued for either all day Drawings or all night Drawings. A Player who wishes to purchase Multi-Draw for both day and night Drawings must select "BOTH" on the Playslip or choose "BOTH" on the Player's wager screen. The cost of a Multi-Draw Ticket/online Play depends on the number of Draws and how many Plays are selected.

"Number of Draws" means the number of Drawings for which a Multi-Draw Purchase is valid.

"Pairs" means a type of Play in which a Player wagers on only two (2) of the three (3) digits in a **Pick 3** number.

"Back Pair" means a type of Play in which a Player wagers on the last two (2) digits of a **Pick 3** number. The Player wins if the last two (2) digits of the **Pick 3** number drawn match EXACTLY the last two (2) **Pick 3** digits on which the wager was placed. An X appears on a **Pick 3** Back Pair retail Ticket to denote the non-wagered digit (Example: X23).

"Front Pair" means a type of Play in which a Player wagers on the first two (2) digits of a **Pick 3** number. The Player wins if the first two (2) digits of the **Pick 3** number drawn match EXACTLY the first two (2) **Pick 3** digits on which the wager was placed. An X appears on a **Pick 3** Front Pair retail Ticket to denote the non-wagered digit (Example: 12X).

"Split Pair" means a type of Play in which a Player wagers on just the first and last digits in a **Pick 3** number. The Player wins if the first and last digits in the **Pick 3** number drawn match EXACTLY the first and last digits in the **Pick 3** number on which the wager was placed. An X appears on a **Pick 3** Split Pair retail Ticket (example: 1X3). Using 1X3 as an example, a Player who wagers \$1.00 on 1X3 in **Pick 3** Pairs would win \$50 if 103, 113, 123, 133, 143, 153, 163, 173, 183, or 193 is drawn. The Prize is \$25 for a \$.50 wager.

The non-wagered digit will be grayed out on a **Pick 3** Pairs online Play.

"Partial Easy Pick" means a Game feature that allows a Player to have the gaming system randomly select a portion of the Player's numbers for an individual Play. The designation "EP" is printed on a retail Ticket to denote a Partial Easy Pick Play.

"Person" means a natural person and may not extend to or be applied to a corporation, company, partnership, association or other entity or when referring to a Lottery retailer, the term as defined in § 58.1-4009 of the Code of Virginia.

"**Pick 3** Cut-off" or "Imminent" means the time after which Lottery Plays will not be accepted for that Drawing. The Imminent occurs daily at 1:53 PM Eastern Time for each **Pick 3** day Drawing and at 10:45 PM Eastern Time for each **Pick 3** night Drawing.

"**Pick 3** Ticket" or "Ticket" means a valid Ticket produced by the Lottery's gaming system and sold by the Virginia Lottery for this Game.

"Play" means one (1) wager for a chance to win a Prize.

"Play Area" means a defined area on a retail Ticket within which distinct numbers, symbols, and/or Game grids are printed that are unique to the Game.

"Player" means a Person who is at least eighteen (18) years of age, who purchases or otherwise validly obtains a Play/Ticket. Licensed Virginia Lottery Retailers and their employees may be Virginia Lottery Players.

"Playslip" means an optically readable card on paper stock issued by the Virginia Lottery or an electronic Playslip created in the official Virginia Lottery Mobile App that a Player uses to make a Play or Plays. A Playslip has no pecuniary or Prize value and shall not constitute evidence of a Ticket purchase or of numbers selected.

"Plays per Ticket" means the number of Plays printed on a single Ticket or displayed online or on the Mobile App. A **Pick 3** Ticket contains up to one (1) Play per Ticket.

"Play Type" means a specific feature of a Play: Exact Order, Any Order, 50/50, Combo, Front Pair, Split Pair, or Back Pair.

"Present at the Terminal" means that a Player remains physically present at the Virginia Lottery Terminal from the time the Player's order for a Ticket is accepted by the Virginia Lottery Retailer, through completion of the order processing, payment, and delivery of the Ticket to the Player. Players must be present at the Terminal for any purchase.

"Prize" or "Prizes" means the winnings as defined in **Section H** ("Prize Structure").

"Prizewinner" means a verified Claimant who is entitled, as a result of successful Play/Ticket validation, to receive a Prize under the rules of a Game.

"Purchase" means the total number of Plays, regardless of wager amount, contained in a single transaction.

"Self-service Vending Machine" or "Vending Machine" means an interactive device by which a Player may select a Game and purchase a Ticket without the help of a retail clerk or a Virginia Lottery employee at a Virginia Lottery office or other approved location.

"System Day" means the time at which a particular day begins in the Lottery's gaming system (4:30 AM Eastern Time) to the time the same day ends in the Lottery's gaming system (1:00 AM Eastern Time the following calendar day).

"Terminal" means a device that is located at a Lottery-authorized retail location or Lottery office and connected to the Lottery Gaming System for the purpose of issuing Tickets, Plays, or an electronic facsimile thereof, and entering, receiving, and processing Game-related transactions.

"Terminal-generated ticket" means a printed paper ticket or digital wager for a drawing issued through a Lottery gaming system to a player as a receipt for the number, numbers, or items or combination of numbers or items, the player has selected.

"Ticket Message" means a message that may appear on each Ticket that consists of up to seven (7) lines, thirty-six (36) characters per line.

"Unclaimed Prize" means any cash Prize for a Winning **Pick 3** Ticket/online Play that has not been presented for payment within 180 days of the Drawing date for which the Ticket/online Play was purchased.

“Winning Number(s)” means the three (3)-digit **Pick 3** number, randomly selected at each Drawing, that will be used to determine the Winning Play.

“Winning Play” means the numbers making up a single Game Play that match the Winning Numbers.

“Winning Ticket/Online Play” means a Ticket/online Play that has passed all Lottery validation and security requirements and contains the Winning Play(s). Each Winning Ticket/online Play must meet Virginia Lottery validation requirements as defined in the Virginia Lottery regulations.

“Winning Ticket/Online Play Validation” means the process used to validate a Winning Ticket/online Play following the purchase of a Winning Play as shown on the **Pick 3** Ticket/online play. Refer to **Section L** (“Ticket/Online Play Validation Requirements”).

C. GAME DESCRIPTION: Pick 3 is a Computer-generated Game in which Players select numbers that could potentially match those selected during a random Drawing for a chance to win Prizes. Refer to **Section H** (“Prize Structure”).

D. ELIGIBILITY:

1. Minors purchasing or redeeming Tickets: Persons under the age of eighteen (18) are not permitted to purchase or redeem Lottery Games/products. No Lottery Game/product shall be given as a gift or otherwise to any Person under the age of eighteen (18) years. The transferee of any Game/product from a Person ineligible to purchase/acquire a Lottery Game/product is ineligible to receive any Prize thereof.
2. Eligibility: No officer, employee or Board member of the Lottery, or any officer or employee or board member of any vendor to the Lottery of Computer-generated or scratch game goods or services working directly on a contract with the Lottery for such goods or services, or any person residing in the same household of any such board member, officer or employee, or any person under the age of eighteen (18) years, shall be eligible to purchase Tickets. The Lottery will not pay a Prize on a Ticket purchased by, for, or gifted to or transferred to anyone referenced in this **Section D**, or to the transferee of such Person.

E. GAME PURCHASE:

1. Eligible Players may purchase Plays or Tickets, as applicable, via a Lottery Terminal at retail, a Self-Service Vending Machine, online at www.valottery.com, via the Mobile App, or by any other means made available by the Virginia Lottery.
2. Price: Except as otherwise noted herein, or as otherwise announced by the Lottery, one (1) **Pick 3** Play costs either a minimum of fifty cents (\$.50) or one dollar (\$1.00). The FIREBALL feature doubles the **Pick 3** Game wager per Play.
3. By purchasing a Play or Ticket, the Player agrees to comply with and abide by the Lottery laws and regulations, these Game Rules, all final decisions of the Director, the *Online Gaming Rules* and *Lottery Account Terms and Conditions*, and all procedures established by the Director for the conduct of the Game.

4. Risk: Players should sign the back of a Ticket after purchase. The Lottery shall not be responsible for any loss incurred as a result of a Player's failure to sign a Ticket. It shall be the sole responsibility of a Player to verify the accuracy of each Game Play printed on the Ticket or the wager information displayed on the wager screen for online play or via Mobile App (to include but not limited to, the cost, the numbers selected, play type(s) (if any), and the date(s) of play).
5. The placing of Plays is done at a Player's own risk. The Player acknowledges that a Lottery Retailer shall be deemed to be acting on behalf of the Player in selecting numbers via the Lottery Terminal.
6. Player responsibility: A Player assumes responsibility for any activities in the Player's Lottery Account when making Game purchases online or via Mobile App.
7. Lottery Responsibility: The Lottery is responsible for reasonable safeguards of a Player's Account data.

F. HOW TO PLAY:

1. A Player must select three (3) numbers, each selected from a field of zero (0) through nine (9), that will together form a unique three (3)-digit **Pick 3** number. A Player may add FIREBALL (also selected from a field of zero (0) through nine (9)) to use in conjunction with the **Pick 3** base numbers.
2. Players must match the numbers selected in their **Pick 3** Play(s) to those drawn by the Lottery on the designated Drawing date at the designated Drawing time, in accordance with the Game rules, in order to be eligible to win a **Pick 3** Prize. A Player using the FIREBALL number must use it to replace one (1) of the digits of the Player's **Pick 3** base number in order to match the drawn **Pick 3** number to win a FIREBALL Prize.
3. Use of Playslips may be required: Lottery Retailers may require the use of Playslips for those Play selections and options that can be executed thereon in order to minimize the risk of error in entering Players' number selections and to expedite service to all Lottery customers. Options not available on the Playslip will be entered manually by the Lottery Retailer at the Player's request. The use of mechanical, electronic, computer-generated or any other non-manual method of marking Playslips is prohibited, unless generated through the official Virginia Lottery Mobile App.
4. Unaccepted Play: If, for any reason, the Player's Play is not accepted, the liability of the Lottery and its Retailer is limited to a refund of the amount paid for the Play.
5. Cut-off of Play: Plays for the day Drawing will be accepted by the computer system until approximately 1:53 PM ET and until approximately 10:45 PM ET for the night Drawing.

G. RETAIL TICKET:

1. Ticket data: A **Pick 3** Ticket consists of one (1) game board containing either:
 - one (1) unique three (3)-digit number, or
 - one (1) two (2)-digit number and an X (denoting the non-wagered digit) in a specified order (if one of the Pairs is selected).*For online play, the non-wagered digit will be grayed out.

The front of the Ticket must show the logo for **Pick 3** with FIREBALL, the date and time of purchase, the price of the Ticket, the game board, the Retailer and Terminal number that produced the Ticket, the Ticket serial number and a bar code representation of the Ticket serial number, and the security code. If the Play was an Easy Pick or Partial Easy Pick Play, the code "EP" must be present. If FIREBALL was purchased, the Ticket must include the words "FIREBALL - YES".

The back of the Ticket must contain a sequential Ticket stock number and general lottery game information and requirements.

I. DRAWINGS:

- Drawings will be held at 1:59 PM Eastern Time and at 11:00 PM Eastern Time, or at a time as determined by the Director, seven (7) days a week, unless otherwise announced by the Lottery. Substitute Drawings will be held at the discretion of the Director.
- The Lottery may digitally stream or televise, either live or delayed, the process of selecting the Winning Numbers. The Lottery will report the results to selected news outlets to inform the public of the Winning Numbers. All Drawing results will be available on the Virginia Lottery's official website, www.valottery.com or through the official Virginia Lottery Mobile App. In the event these methods of informing the public of the results are prevented for any reason, the Lottery will use alternate means to inform the public at the earliest reasonable opportunity.
- All Winning Numbers, even though announced, are subject to validation by the Lottery, including, if necessary, review by the Director, whose decision is final. The Lottery shall not be liable for media misprints or incorrectly announced or scrolled Winning Numbers. The Lottery shall not be liable for any information pertaining to Virginia Lottery games, including drawing numbers and prizes, that are shown on other websites and/or mobile applications.

J. RETAIL TICKET OWNERSHIP:

1. A Ticket is a bearer instrument. When a signature is written on the back of a Ticket, the Person whose signature appears in such area shall be the owner of the Ticket and shall be entitled to any Prize resulting from the Ticket. The Lottery shall pay the Claimant whose signature appears on the back of the Winning Ticket.
2. If more than one (1) signature appears on the Ticket or there are multiple parties presenting one Ticket, **each** Prizewinner shall complete a [Prizewinner Claim Form](#) and a [Player Affidavit of Multiple Ownership](#) in order to receive payment. Certain restrictions may apply to the minimum amount of an individual Prizewinner's payment.
3. Non-Responsibility: The Lottery shall not be responsible for lost, stolen, altered, forged, or fraudulently made Tickets.

K. CLAIMANT VERIFICATION:

1. Methods used by the Lottery to establish and confirm a Claimant's identity include, but are not limited to:
 - viewing and/or copying the Claimant's valid government-issued photo identification;
 - viewing and/or copying proof of taxpayer identification number (e.g., Social Security number);
 - asking identity-verifying questions in the absence of the aforementioned document proof; and/or
 - viewing and/or retaining the information provided on a Lottery [Prizewinner Claim Form](#).
2. **In order to verify a Claimant's age, in all cases involving a cash Prize greater than \$100 claimed at a Lottery office,** the Lottery must be provided with the Claimant's valid government-issued photo identification and taxpayer identification number (e.g., Social Security number). Payment will be delayed until such number is provided and the Claimant shall not be entitled to interest on the prize funds attributable to such delay. Any Prize for which a taxpayer identification number has been requested but not furnished within 180 days of the date of the Drawing from which the Winning Play resulted will be forfeited and treated as an Unclaimed Prize.

L. TICKET/ONLINE PLAY VALIDATION REQUIREMENTS:

1. To be a valid Ticket/online Play, all requirements unique to the particular Game and all requirements set out in regulation and law must be met.
2. The Ticket/online Play must have been issued by the Lottery in an authorized manner. A printed Ticket must be intact and must not, in whole or in part, be defectively printed, produced in error, counterfeit, unreadable, incomplete, mis-registered, defective, torn, stolen, mutilated, altered, reconstituted, tampered with, or previously paid.
3. The Ticket/online Play data must have been recorded in the Lottery's central computer system prior to cashing/claiming a prize.
4. The information appearing on the Ticket/online Play must correspond precisely with the Lottery's computer records.
5. The serial number on a retail Ticket must appear in its entirety and must correspond to a matching serial number on the Lottery's validation file.
6. All information appearing on an apparent Winning Ticket must correspond to the Lottery's records of Winning Tickets, and no Prize based upon a Ticket with identical data shall be or have been paid.

7. The display printing on the retail Ticket must be regular in every respect, must correspond precisely to the artwork on file at the Lottery, and must pass all other security criteria determined by the Director.
8. The Ticket/online Play must be validated in accordance with the provisions of the Lottery regulations relating to procedures for claiming Prizes and for the payment thereof.
9. An apparent printed Winning Ticket shall be void unless the Ticket is printed on a paper stock roll issued by the Lottery and in use at the time of the Play and validly issued to the Lottery Retailer from whom the Ticket was purchased.
10. If a Ticket/online Play fails to pass all of the validation requirements set forth in these Game Rules or in the Lottery's regulations, the Ticket/online Play shall be void and ineligible for any Prize and shall not be paid.

M. PRIZE CLAIMS:

1. A retail Ticket shall be the only proof of a Play. Submission of a Winning Ticket to a Lottery Customer Service Center/Prize Zone or through the Lottery Mobile Application or its authorized Lottery Cashing Retailer shall be the sole method of claiming a Prize or Prizes unless purchased online. Prize claims for online purchase shall be handled in accordance with the *Online Gaming Rules* and the *Lottery Account Terms and Conditions*.
2. All claims must be made within 180 days of the date of the drawing. Any cash Prize not claimed within the specified period shall be forfeited and revert to the Virginia State Literary Fund.
3. In accordance with the provisions of the Servicemembers Civil Relief Act, 50 U.S.C.S. app. §§ 501-597b, any Person while in active military service may claim exemption from the 180-day Ticket redemption requirement. Any such Person must claim the forfeited Prize by presenting the Winning Ticket no later than 180 days after discharge from active military service. Within thirty (30) days of such presentation, the Director shall verify the claim and direct payment in accordance with the Lottery regulations then in effect regarding the manner of payment of Prizes to the holders of Winning Tickets or shares.
4. Employees of the Lottery or of a Cashing Lottery Retailer shall verify the Ticket and, if valid, pay the amount due to the Claimant. If a claim form is required, the Claimant will be so advised. No payment shall be made unless the Claimant presents a valid Winning Ticket.
5. A Claimant shall bear all risk of loss or damage incurred by sending a Ticket through the mail or other delivery service, regardless of delivery confirmation status.
6. Prizes may be claimed via the following methods:

7. Virginia Lottery law prohibits the holder of a Winning Ticket from reselling or having a Person other than the Winning Ticket holder claim a Winning Ticket for the purpose of concealing the Winning Ticket holder's identity as a Prizewinner. Any Person found to have engaged in the foregoing shall be fined as determined by the Director: (a) for Prizes of less than \$1,000, not more than \$250; (b) for Prizes of \$1,000 or more but less than \$5,000, more than \$250 but not more than \$500; and (c) for Prizes of \$5,000 or more, no less than \$1,000.

N. PRIZE PAYMENT:

1. When paying any Prize claim **in excess of \$600**, the Lottery shall report the winnings or withhold taxes pursuant to rules established by the Internal Revenue Service and Virginia Department of Taxation and shall file the appropriate income reporting form(s) with the Internal Revenue Service and the Virginia Department of Taxation.
2. When paying a cash Prize claim **in excess of \$100** at a Lottery office, the Lottery shall withhold any monies due under the Commonwealth's Set-Off Debt Collection Act if the agency has registered such debt with the Virginia Department of Taxation and timely notice of the debt has been furnished by the Virginia Department of Taxation to the Lottery.
3. One Prize: Subject to the validation requirements contained herein, Players are eligible to receive only one (1) (the highest) applicable Prize for each Winning Game Play.
4. No right of any Person to a Prize shall be assignable except that:
 - a. the Lottery may pay any Prize according to the terms of a deceased Prizewinner's beneficiary designation or similar form filed with the Lottery, or to the estate of a deceased Prizewinner who has not completed such a form; and
 - b. the Prize to which a Prizewinner is entitled may be paid as directed by an appropriate judicial order.
5. Each Prizewinner is legally required to include the value of the Prize, as well as any taxes paid by the Lottery on the Prizewinner's behalf, in the Prizewinner's taxable income for tax reporting purposes. As a result of accepting a Prize, and taking into account a Prizewinner's total taxable income for the year in which the Prize is accepted, a Prizewinner may fall into a higher tax bracket for The Prizewinner's federal and state tax liabilities for the year in which the Prize is accepted.
6. Virginia law prohibits the disclosure of information about an individual Prizewinner's identity (Name, home town, amount won) unless that Prizewinner consents in writing to such disclosure.
7. The agency may use a Prizewinner's photograph and conduct a press conference with a Prizewinner, provided the agency obtains the prior written consent of the Prizewinner.
8. No consideration shall be paid by the agency to a Prizewinner for the use of the Prizewinner's photograph .

O. CANCELLATION POLICY: Once printed or purchased online, a **Pick 3** Ticket purchased from a Self-Service Vending Machine or an online **Pick 3** Play **cannot be canceled**.

A Ticket purchased from a Retailer **can** be canceled by the Retailer using the same Terminal on which the Ticket was purchased, provided such cancellation takes place **(a)** on the same day of purchase and **(b)** prior to the Imminent, **and provided the Ticket was not purchased in connection with a Promotion**. Tickets can only be canceled by scanning the Ticket barcode.

1. Canceled Drawings or sales: The Director has the right to cancel Drawings or sales, either or both, of Games on holidays, days of special importance, or on days when conditions make conducting the Drawings or sales impractical or inappropriate and to conduct Drawings or makeup Drawings at times and dates as determined by the Director. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such re-schedule/cancellation.
2. The Lottery may discontinue selling any specific set of numbers under a sellout provision if the potential prize liability for any particular number combination exceeds an amount determined by the Lottery for the Game.
3. Termination of Game: The Director may, at any time, announce a suspension or termination of a Game without advance notice and at the Director's sole discretion, at which point no further Tickets/online Plays will be sold and no additional Prizes shall be awarded. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Board shall have any liability whatsoever for any such suspension/termination.

P. DISPUTES: The Director may refrain from paying a Prize pending final determination under any of the following circumstances:

1. If a dispute related to any Prize occurred or if it appears that a dispute may occur;
2. If there is any question regarding the identity of the Claimant; or
3. If there is any question regarding the validity of any Ticket presented for payment.

No liability for interest arising because of any such delay, or any delay beyond the Lottery's control, shall accrue to the benefit of the Claimant pending payment of the claim. The Lottery is neither liable for, nor has it any responsibility to resolve, disputes between or among competing Claimants.

In the event of a dispute or other instance of doubt, the decision of the Director shall be final and binding. However, the Director may, solely at the Director's option, refund the purchase price of a Ticket/online Play or replace an invalid, defective or otherwise erroneous Ticket/online Play with a Ticket/online Play of equivalent sale price from any current Lottery game. Replacement of the Ticket/online Play shall be the bearer's or Claimant's sole and exclusive remedy.

Q. GOVERNING LAW:

By purchasing this Game, each person agrees to comply with and abide by the Lottery laws and Lottery regulations, all final decisions of the Director of the Lottery, these and any other applicable Rules established by the Lottery Board and/or Director of the Lottery for the conduct of this Game, and the *Lottery Account Terms and Conditions*, as applicable. Any dispute arising that relates to any aspect of this Game shall be governed by the laws of the Commonwealth of Virginia, and the venue for the determination of any such dispute shall be in the city of Richmond, Virginia.

R. AMERICANS WITH DISABILITIES ACT ("ADA"):

The Lottery is not responsible for any third party's compliance with ADA Rules and Regulations where applicable in connection with a Prize.
