I. **PURPOSE:**

The Virginia Lottery ("Lottery"), an independent agency of the Commonwealth of Virginia, is seeking bids from qualified companies to establish a Contract for Lottery scratch ticket in-counter dispensers ("ICD") and replacement drawers.

II. **PRODUCT AND/OR SERVICE REQUIREMENTS:**

The Contractor shall supply scratch ticket in-counter dispensers, replacement drawers and miscellaneous parts in accordance with the following specifications and production requirements.

A. **In-Counter Dispensers**

1. **16 Game In-Counter Dispenser**

Specifications for 16 game in-counter dispenser with number tabs. Purchase of new dispenser shall include all parts listed below.

Upper unit frame and surround consisting of:

- Aluminum frame (colored or bare) sized 18.375" x 18.375" to fit into a hole cut in a convenience store counter. A .75" upper flange on frame extends onto the counter and supports the unit.
- White ABS plastic surround (.110" x 5.75" x 55.5") attached to the aluminum frame with rivets. The plastic surround is slotted on the sides for attaching the base portion and on the customer side to hold the display tray supports at varying heights.
- A one (1) piece shaped ABS "stiffening" piece shall be riveted into the surround.
- One (1) piece of 18.125" x 18.125" tempered glass sealed into the aluminum frame with double stick tape and vinyl acrylic latex caulk.
- Two (2) detachable display tray supports
- Two "mounting pegs" to support the display tray on the clerk side of the unit.
- A suction cup shall be supplied with the original unit to assist in replacing the top removable glass.

Display tray of .110" ABS plastic approximately 17.5" x 17.5"

- The Lottery will specify either white or black ABS for the tray.
- The method of displaying the tickets shall be plastic uprights with "J" channel to hold games in place. Built-in number tabs identify each game.

Dispensing base with overall size of 13.25" deep x 18.5" wide x 10.5" tall

- 16 game base holds four (4) drawers.
- Base, sides and back is .160" white ABS plastic with .110" tray supports glued into slots.

- Base bottom is .110" white ABS. One (1) piece "U" with a flanged back.
- Base shall be slotted to accommodate the lock bolt in the drawer locks.
- Mounting hardware to attach base to upper frame and surround include: four (4) ¼" x 20 x ¾" carriage bolts, four (4) ¼" x 20 wing nuts, eight (8) ¼" washers.

Dispensing drawers for ticket packs up to 12" long each having:

- A one (1) piece heat bent base of .110" white ABS plastic (with ticket pack surface, vertical front, "ticket tightener" surface and retaining tabs bent on each side of the tray to prevent tampering.
- "Ticket tighteners" shall be injection molded clear ABS plastic.
- Each drawer shall have three (3) vertical dividers of .160" white ABS plastic glued to the tray in the ticket surface area. Two (2) removable ¼" thick x 17.25" hold down rods are attached in holes through these dividers.

Replaceable tempered top glass is 0.156" (5/32") x 18.125" x 18.125", note: length and width measurements are allowed a plus or minus of .063 (1/16").

## 2. **20 Game In-Counter Dispenser**

Specifications for 20 game in-counter dispenser with number tabs. Purchase of new dispenser shall include all parts listed below.

Upper unit frame and surround consisting of:

- Aluminum frame (colored or bare) sized 18.375" x 18.375" to fit into a hole cut in a convenience store counter. A .75" upper flange on frame extends onto the counter and supports the unit.
- White ABS plastic surround (.110" x 5.75" x 55.5") attached to the aluminum frame with rivets. The plastic surround is slotted on the sides for attaching the base portion and on the customer side to hold the display tray supports at varying heights.
- A one (1) piece shaped ABS "stiffening" piece shall be riveted into the surround.
- One (1) piece of 18.125" x 18.125" tempered glass sealed into the aluminum frame with double stick tape and vinyl acrylic latex caulk.
- Two (2) detachable display tray supports
- Two (2) "mounting pegs" to support the display tray on the clerk side of the unit.
- A suction cup shall be supplied with the original unit to assist in replacing the top removable glass.

Display tray of .110" ABS plastic approximately 17.5" x 17.5"

- The Lottery will specify either white or black ABS for the tray.

- The method of displaying the tickets shall be plastic uprights with “J” channel to hold games in place. Built-in number tabs identify each game.

Dispensing base with overall size of 13.25” deep x 18.5” wide x 10.5” tall

- 20 game base holds five (5) drawers.
- Base, slides and back is .160” white ABS plastic with .110” tray supports glued into slots.
- Base bottom is .110” white ABS. One (1) piece “U” with a flanged back.
- Base shall be slotted to accommodate the lock bolt in the drawer locks.
- Mounting hardware to attach base to upper frame and surround include: four (4) ¼” x 20 x ¾” carriage bolts, four (4) ¼” x 20 wing nuts, eight (8) ¼” washers.

Dispensing drawers for ticket packs up to 12” long each having:

- A one (1) piece heat bent base of .110” white ABS plastic with ticket pack surface, vertical front, “ticket tightener” surface and retaining tabs bent on each side of the tray to prevent tampering.
- “Ticket tighteners” shall be injection molded clear ABS plastic.
- Each drawer shall have three (3) vertical dividers of .160” white ABS plastic glued to the tray in the ticket surface area. Two (2) removable ¼” thick x 17.25” hold down rods are attached in holes through these dividers.

Replaceable tempered top glass is 0.156” (5/32”) x 18.125” x 18.125”, note: length and width measurements are allowed a plus or minus of .063 (1/16”).

### 3. **24 Game In-Counter Dispenser**

Specifications for 24 game in-counter dispenser with number tabs. Purchase of new dispenser shall include all parts listed below.

Upper unit frame and surround consisting of:

- Aluminum frame (colored or bare) sized 18.375” x 18.375” to fit into a hole cut in a convenience store counter. A .75” upper flange on frame extends onto the counter and supports the unit.
- White ABS plastic surround (.110” x 5.75” x 55.5”) attached to the aluminum frame with rivets. The plastic surround is slotted on the sides for attaching the base portion and on the customer side to hold the display tray supports at varying heights.
- A one (1) piece shaped ABS “stiffening” piece shall be riveted into the surround.
- One (1) piece of 18.125” x 18.125” tempered glass sealed into the aluminum frame with double stick tape and vinyl acrylic latex caulk.
- Two (2) detachable display tray supports

- Two “mounting pegs” to support the display tray on the clerk side of the unit.
- A suction cup shall be supplied with the original unit to assist in replacing the top removable glass.

Display tray of .110” ABS plastic approximately 17.5” x 17.5”

- A one (1) piece shaped ABS "stiffening" piece shall be riveted into the surround.
- One (1) piece of 18.125" x 18.125" tempered glass sealed into the aluminum frame with double stick tape and vinyl acrylic latex caulk.
- Two (2) detachable display tray supports
- Two "mounting pegs" to support the display tray on the clerk side of the unit.

Display tray of .110" ABS plastic approximately 17.5" x 17.5"

Dispensing base with overall size of 13.25" deep x 18.5" wide x 10.5" tall

- 28 game base holds seven (7) drawers.
- Base, sides and back is .160" white ABS plastic with .110" tray supports glued into slots.
- Base bottom is .110" white ABS. One (1) piece "U" with a flanged back.
- Base shall be slotted to accommodate the lock bolt in the drawer locks.
- Mounting hardware to attach base to upper frame and surround include: four (4) ¼" x 20 x ¼" carriage bolts, four (4) ¼" x 20 wing nuts, eight (8) ¼" washers.

Dispensing drawers for ticket packs up to 12" long each having:

- A one (1) piece heat bent base of .110" white ABS plastic with ticket pack surface, vertical front, "ticket tightener" surface and retaining tabs bent on each side of the tray to prevent tampering.
- "Ticket tighteners" shall be injection molded clear ABS plastic.
- Each drawer shall have three (3) vertical dividers of .160" white ABS plastic glued to the tray in the ticket surface area. Two (2) removable ¼" thick x 17.25" hold down rods are attached in holes through these dividers.

Specifications for 32 game in-counter dispenser with number tabs. Purchase of new dispenser shall include all parts listed below.

Upper unit frame and surround consisting of:

- Aluminum frame (colored or bare) sized 18.375" x 18.375" to fit into a hole cut in a convenience store counter. A .75" upper flange on frame extends onto the counter and supports the unit.
- White ABS plastic surround (.110" x 5.75" x 55.5") attached to the aluminum frame with rivets. The plastic surround is slotted on the sides for attaching the base portion and on the customer side to hold the display tray supports at varying heights.
- A one (1) piece shaped ABS "stiffening" piece shall be riveted into the surround.
- One (1) piece of 18.125" x 18.125" tempered glass sealed into the aluminum frame with double stick tape and vinyl acrylic latex caulk.
- Two (2) detachable display tray supports
- Two "mounting pegs" to support the display tray on the clerk side of the unit.
- A suction cup shall be supplied with the original unit to assist in replacing the top removable glass.

Display tray of .110" ABS plastic approximately 17.5" x 17.5"

- The Lottery shall specify either white or black ABS for the tray.
- The method of displaying the tickets shall be plastic uprights with "J" channel to hold the games in place. Built-in number tabs shall identify each game.

Dispensing base with overall size of 13.25" deep x 18.5" wide x 10.5" tall

- 32 game base holds eight (8) drawers.
- Base, sides and back is .160" white ABS plastic with .110" tray supports glued into slots.
- Base bottom is .110" white ABS. One (1) piece "U" with a flanged back.
- Base shall be slotted to accommodate the lock bolt in the drawer locks.
- Mounting hardware to attach base to upper frame and surround include: four (4) 1/4" x 20 x 3/4" carriage bolts, four (4) 1/4" x 20 wing nuts, eight (8) 1/4" washers.

Dispensing drawers for ticket packs up to 12" long each having:

- A one (1) piece heat bent base of .110" white ABS plastic (with ticket pack surface, vertical front, "ticket tightener" surface

and retaining tabs bent on each side of the tray to prevent tampering.

- “Ticket tighteners” shall be injection molded clear ABS plastic.
- Each drawer shall have three (3) vertical dividers of .160” white ABS plastic glued to the tray in the ticket surface area. Two (2) removable ¼” thick x 17.25” hold down rods are attached in holes through these dividers.

Replaceable tempered top glass is 0.156” (5/32”) x 18.125” x 18.125”, note: length and width measurements are allowed a plus or minus of .063 (1/16”).

#### 6. **28 Game Remote Base**

Shell:

- Bottom - .110” white ABS, 13.5” x 21.25”, flange drilled for mounting screws
- Top - .110” white ABS, 13.375” x 18.5”
- Back and sides - .160” white ABS, tray supports - .110” white ABS
- 28 game = 18 5/8” tall (seven drawers)

Dispensing drawers:

- Base - .110” white ABS 14.75” x 17.875”
- Dividers (3) - .160” white ABS x 2.125” x 6”
- Retainer strip - .160” white ABS x .75” x 17.25”
- Hold downs - .25” acrylic rod 17” long
- Four (4) nylon keepers for hold downs
- Four (4) injection molded “ticket tighteners” with two (2) nylon rollers each
- One (1) lock with two (2) keys

Note: The base unit is slotted on both sides so that it is “reversible” and can be mounted on top of a shelf or counter and may be reversed so it can mount up under a counter or shelf.

#### 7. **32 Game Remote Base**

Shell:

- Bottom - .110” white ABS, 13.5” x 21.25”, flange drilled for mounting screws
- Top - .110” white ABS, 13.375” x 18.5”
- Back and sides - .160” white ABS, tray supports - .110” white ABS
- 32 game = 21 1/8” tall (eight drawers)

Dispensing Drawers:

- Base - .110” white ABS 14.75” x 17.875”
- Dividers (3) - .160” white ABS x 2.125” x 6”
- Retainer strip - .160” white ABS x .75” x 17.25”
- Hold downs - .25” acrylic rod 17” long

- Four (4) nylon keepers for hold downs
- Four (4) injection molded “ticket tighteners” with two (2) nylon rollers each
- One (1) lock with two (2) keys

Note: The base unit is slotted on both sides so that it is “reversible” and can be mounted on top of a shelf or counter and may be reversed so it can mount up under a counter or shelf.

#### 8. **36 Game Remote Base**

Shell:

- Bottom - .110” white ABS, 13.5” x 21.25”, flange drilled for mounting screws
- Top - .110” white ABS, 13.375” x 18.5”
- Back and sides - .160” white ABS, tray supports - .110” white ABS
- 36 game = 23.5” tall (nine drawers)

Dispensing Drawers:

- Base - .110” white ABS 14.75” x 17.875”
- Dividers (3) - .160” white ABS x 2.125” x 6”
- Retainer strip - .160” white ABS x .75” x 17.25”
- Hold downs - .25” acrylic rod 17” long
- Four (4) nylon keepers for hold downs
- Four (4) injection molded “ticket tighteners” with two (2) nylon rollers each
- One (1) lock with two (2) keys

Note: The base unit is slotted on both sides so that it is “reversible” and can be mounted on top of a shelf or counter and may be reversed so it can mount up under a counter or shelf.

#### 9. **24 to 28 Conversion Kit**

Note: Upper metal frame and plastic surround installed in the countertop remain in place. Attach new 28 game base to this upper unit. Use existing six (6) drawers and new drawer supplied to complete this conversion.

Dispensing base with overall size of 13.25” deep x 18.5” wide x 18” tall

- Base shall be .160 white ABS plastic with .110” tray supports glued into slots.
- Base bottom is a one (1) piece “U” with a flanged back (.110” white ABS) attached using ultrasonic “welding”.
- Base shall be slotted to accommodate the drawer lock bolt.
- Mounting hardware to attach base to the existing upper frame and surround include: four (4) ¼ x 20 x ¾” carriage bolts, four (4) ¼” x 20 wing nuts, eight (8) ¼” washers.

Dispensing drawer for ticket packs up to 12" long. One (1) drawer included with conversion.

- A one (1) piece heat bent base of .110" white ABS plastic with ticket pack surface, vertical front, "ticket tightener" surface and retaining tabs bent on each side of the drawer to prevent tampering.
- Four (4) "ticket tighteners" injection molded clear ABS plastic on each drawer.
- Each drawer shall have three (3) vertical dividers of .160" white ABS plastic glued to the drawer in the area.
- Two (2) removable ¼" thick x 17.25" hold down rods are attached in holes through these dividers.

10. **24 to 32 Conversion Kit**

Note: Upper metal frame and plastic surround installed in the countertop remain in place. Attach new 32 game base to this upper unit. Use existing six (6) drawers and two (2) new drawers supplied to complete this conversion.

Dispensing base with overall size of 13.25" deep x 18.5" wide x 20 1/2" tall

- Base shall be .160" white ABS plastic with .110" tray supports glued into slots.
- Base bottom shall be a one (1) piece "U" with a flanged back (.110" white ABS) attached using ultrasonic "welding".
- Base shall be slotted to accommodate the drawer lock bolt.
- Mounting hardware to attach base to the existing upper frame and surround include: four (4) ¼ x 20 x ¾" carriage bolts, four (4) ¼" x 20 wing nuts, eight (8) ¼" washers.

Dispensing drawers for ticket packs up to 12" long. Two (2) drawers included with conversion.

- A one (1) piece heat bent base of .110" white ABS plastic with ticket pack surface, vertical front, "ticket tightener" surface and retaining tabs bent on each side of the drawer to prevent tampering.
- Four (4) "ticket tighteners" injection molded clear ABS plastic on each drawer.
- Each drawer shall have three (3) vertical dividers of .160" white ABS plastic glued to the drawer in the area.
- Two (2) removable ¼" thick x 17.25" hold down rods are attached in holes through these dividers.

**B. Replacement Drawers and Miscellaneous Parts**

1. **Replacement Drawers**

Dispensing drawers for ticket packs up to 12" long each having:

- A one (1) piece heat bent base of .110" white ABS plastic with ticket pack surface, vertical front, "ticket tightener"

surface and retaining tabs bent on each side of the tray to prevent tampering.

- “Ticket tighteners” shall be injection molded clear ABS plastic.
- Each drawer shall have three (3) vertical dividers of .160” white ABS plastic glued to the drawer in the ticket surface area. Two (2) removable ¼” thick x 17.25” hold down rods shall be attached in holes through these dividers.

2. **Display Ticket Number Sets 1-24**

- Specify 1-24 when ordering number sets.
- Plastic clip on numbers are 1/16” thick x 1-1/16” x 1-1/2”.
- ¼” black numbers printed on each clip
- Corresponding numbered paper labels are sent for the individual ticket dispensing slots on the clerk’s side of the unit.

3. **Display Ticket Number Sets 25-48**

- Specify 25-48 when ordering number sets.
- Plastic clip on numbers are 1/16” thick x 1-1/16” x 1-1/2”.
- ¼” black numbers printed on each clip
- Corresponding numbered paper labels are sent for the individual ticket dispensing slots on the clerk’s side of the unit.

4. **In-Counter Dispenser Covers (ICD Covers), White**

- White plastic replacements for the top glass in on-counter dispensers
- Standard size units with glass 18-3/16” x 18-3/16” use white plastic .160” x 18” x 18”

5. **In-Counter Dispenser Covers (ICD Covers), Black**

- Black plastic replacements for the top glass in on-counter dispensers.
- Standard size units with glass 18-3/16” x 18-3/16” use black plastic .160” x 18” x 18”

6. **1 Drawer Slide on Base Without Display Tray**

**“Slide On” Base Extension**

- 1) “Slide on” dispensing base with overall size of 13.25” deep x 18.5” wide x 2.75” tall with 2.75” wings to attach unit to existing dispenser.
  - One (1) drawer holds four (4) games.
  - Base shall be .160” white ABS plastic.
  - Base bottom and top are .110” white ABS, glued with reinforcements.
  - Base shall be slotted to accommodate the lock bolt in the drawer locks.
  - No mounting hardware is required but Super Glue may be used in the seam.
- 2) One (1) dispensing drawer for ticket packs up to 12” long.

**D. Shipping and Delivery**

1. The Lottery will communicate to the Contractor the need for dispensers, drawers or parts by issuing a Lottery Term Contract Release (TCR) form. This form will indicate the Contract Number, dispenser/drawer/part desired, exact quantity to be delivered, delivery location, and any other details specific to the order.
2. The order will be sent to the manufacturer for fulfillment and shipped directly to the retailer location.
3. Contractor shall package and ship dispensers, drawers and parts in a manner to prohibit damage during delivery.
4. All shipments shall be F.O.B. Destination.
5. All shipping charges shall be borne by the Contractor and included in the "each" price of each item listed in the Pricing Schedule.

**E. Warranty**

1. Contractor shall warrant all dispensers, drawers and parts shall be free of defects in materials and workmanship for a period of at least one (1) year from date of receipt by the Lottery.
2. Contractor shall replace any defective or damaged dispenser, drawer, part at no additional cost to the Lottery upon receipt from the Lottery of the defective or damaged component. All shipping of defective or damaged dispensers returned to the Contractor shall be borne by the Contractor.

**III. SPECIAL TERMS AND CONDITIONS:**

**A. AUDIT:**

The Contractor shall retain all books, records, and other documents relative to this Contract for five (5) years after final payment, or until audited by the Commonwealth of Virginia, whichever is sooner. The Lottery, its authorized agents, and/or state auditors shall have full access to and the right to examine any of said materials during said period.

**B. AWARD:**

The Lottery will make the award on a Grand Total basis to the lowest responsive and responsible Bidder. The Purchasing Office reserves the

right to conduct any test it may deem advisable and to make all evaluations. The Lottery also reserves the right to reject any or all bids, in whole or in part, to waive informalities and to delete items prior to making the award, whenever it is deemed, in the sole opinion of the Lottery, to be in its best interest. Delivery time may also factor into decision to award.

C. **BID ACCEPTANCE PERIOD:**

Any bid in response to this solicitation shall be valid for 90 days. At the end of the 90 days the bid may be withdrawn at the written request of the Bidder. If the bid is not withdrawn at that time it remains in effect until an award is made or the program is canceled.

D. **BID PRICES:**

Bid shall be in the form of a firm unit price for each item during the Contract period.

E. **CANCELLATION OF CONTRACT:**

The Lottery reserves the right to cancel and terminate any resulting Contract, in part or in whole, without penalty, upon 60 days written notice to the Contractor. In the event the initial Contract period is for more than 12 months, the resulting Contract may be terminated by either party, without penalty, after the initial 12 months of the Contract period upon 60 days written notice to the other party. Any Contract cancellation notice shall not relieve the Contractor of the obligation to deliver and/or perform on all outstanding orders issued prior to the effective date of cancellation.

F. **DISCOUNTS, PROMPT PAYMENT:**

Discounts for prompt payment will not be calculated in determining net low bid. Discounts for prompt payment will be shown on the purchase order/Contract and taken if invoices are processed and payment made within the stipulated time frame. If discounts are not offered, payment shall be made 30 days after receipt of an accurate invoice by the Lottery's Accounts Payable Department. Bidder shall indicate discount (if applicable) within the "Pricing section" near the end of this solicitation.

G. **EXTRA CHARGES NOT ALLOWED:**

The bid price shall be for in-counter dispensers and replacement drawers ready for the Lottery's use and shall include all applicable freight and installation charges; extra charges will not be allowed.

H. **FINAL INSPECTION:**

In the event a Bidder is offering an "approved equal", the Contractor shall demonstrate to the Lottery that the in-counter dispensers and replacement drawers are fully operational and in compliance with contract specifications and codes. Any deficiencies shall be promptly and permanently corrected by the Contractor at the Contractor's sole



expense prior to final acceptance of the work.

Contractor agrees to indemnify and hold harmless the Commonwealth, the Lottery, their officers, directors, agents and employees (collectively, "Commonwealth's Indemnified Parties") from and against any and all losses, damages, claims, demands, proceedings, suits and actions, including any related liabilities, obligations, losses, damages, assessments, fines, penalties (whether criminal or civil), judgments, settlements, expenses (including attorneys' and accountants' fees and disbursements) and costs (each, a "Claim" and collectively, "Claims"), incurred by, borne by or asserted against any of Commonwealth's Indemnified Parties to the extent such Claims in any way relate to, arise out of or result from: (i) any intentional or willful conduct or negligence of any employee, agent, or subcontractor of the Contractor, (ii) any act or omission of any employee, agent, or subcontractor of the Contractor, (iii) breach of any representation, warranty or covenant of the Contractor contained herein, (iv) any defect in the Contractor-provided products or services, or (v) any actual or alleged infringement or misappropriation of any third party's intellectual property rights by any of the Contractor-provided products or services. Selection and approval of counsel and approval of any settlement shall be accomplished in accordance with all applicable laws, rules and regulations. For state agencies, the applicable laws include §§ 2.2-510 and 2.2-514 of the *Code of Virginia*. In all cases involving the Commonwealth or state agencies, the selection and approval of counsel and approval of any settlement shall be satisfactory to the Commonwealth.

In the event that a Claim is commenced against any of Commonwealth's Indemnified Parties alleging that use of the Contractor-provided products or services, including any components thereof, or that the Contractor's performance or delivery of any product or service under this Contract infringes any third party's intellectual property rights and the Contractor is of the opinion that the allegations in such Claim in whole or in part are not covered by this indemnification provision, Contractor shall immediately notify the Lottery in writing, via certified mail, specifying to what extent the Contractor believes it is obligated to defend and indemnify under the terms and conditions of this Contract. The Contractor shall in such event protect the interests of the Commonwealth's Indemnified Parties and secure a continuance to permit the Lottery to appear and defend their interests in cooperation with the Contractor as is appropriate, including any jurisdictional defenses the Lottery may have.

In the event of a Claim pursuant to any actual or alleged infringement or

misappropriation of any third party's intellectual property rights by any of the Contractor-provided Deliverables, Products, Software, Services, Solution, including Solution Components, Application and Licensed Services, as applicable, or Contractor's performance, and in addition to all other obligations of the Contractor in this Section, the Contractor shall at its expense, either (a) procure for all Authorized Users the right to continue use of such infringing Deliverables, Products, Software, Services, Solution, including Solution Components, Application and Licensed Services, as applicable, or any component thereof; or (b) replace or modify such infringing Deliverables, Products, Software, Services, Solution, including Solution Components, Application and Licensed Services, as applicable, or any component thereof, with non-infringing Deliverables, Products, Software, Services, Solution or Solution Component(s), Application and Licensed Services, as applicable, satisfactory to the Lottery. And in addition, the Contractor shall provide any the Lottery with a comparable temporary replacement products and/or services or reimburse the Lottery for the reasonable costs incurred by the Lottery in obtaining an alternative product or service, in the event the Lottery cannot use the affected Deliverable, Product, Software, Services, Solution or Solution Component(s), Application and Licensed Services, as applicable, or any component thereof. **L. NEW AND/OR ADDITIONAL EQUIPMENT:**

**M. NEW EQUIPMENT:**

Unless otherwise expressly stated in this solicitation, any equipment furnished under the Contract shall be new, unused equipment.

N. **PERFORMANCE, CONTRACTOR:**

Contractors providing goods and services to the Lottery are required to perform in accordance with the terms and conditions of their Contract. When contractual requirements are not met, the following actions may be taken (at the Lottery's option):

1. **Contractor Complaint Form:**

If a Contractor fails to perform in accordance with the terms and conditions of the Contract, the Lottery will prepare a Contractor Complaint Form and forward to the Purchasing Office. This form will be sent to the Contractor for a corrective action plan.

2. **Default:**

3. **Ineligible for Award:**

Once placed in default, the Contractor will be ineligible to do business with the Lottery for purchases exceeding \$5,000 for a period of **three (3) years**.

4. **Re-procurement of Goods and Services:**

In addition to a Contractor's ineligibility for award of programs over \$5,000, the Lottery may procure the goods and/or services from other sources and hold the Contractor responsible for the price difference of the original Contract amount and the amount of the new Contract. The Lottery will follow competitive principles as outlined herein for the re-procurement.

The vendor will remain in default until the re-procurement costs have been paid to the Lottery. The vendor is still subject to the three (3) year ineligibility based on the default regardless as to when the re-procurement cost is paid.

5. **Number of Complaints:**

O. **PRE-AWARD CONFERENCE:**

The Lottery will have the option to request a conference call, prior to award, with the apparent low Bidder to ensure the Bidder clearly understands all requirements of the solicitation. The Bidder shall include in the conference call the individual(s) who will be fulfilling the Contractual requirements.

P. **PRIME CONTRACTOR RESPONSIBILITIES:**

The Contractor shall be responsible for completely supervising and directing the work under this Contract and all subcontractors that he may utilize, using his best skill and attention. Subcontractors who perform work under this Contract shall be responsible to the prime Contractor. The Contractor agrees that he is as fully responsible for the acts and omissions of his subcontractors and of persons employed by them as he is for the acts and omissions of his own employees.

Q. **PRODUCT AVAILABILITY/SUBSTITUTION:**

Substitution of a product, brand or manufacturer after the award of Contract is expressly prohibited unless approved in writing by the Contract Specialist. The Lottery may, at its discretion, require the Contractor to provide a substitute item of equivalent or better quality subject to the approval of the Contract Specialist, for a price no greater than the Contract price, if the product for which the Contract was awarded becomes unavailable to the Contractor.

R. **PRODUCT INFORMATION:**

If a Bidder is offering an "approved equal", the Bidder shall clearly and specifically identify the product being offered and enclose complete and detailed descriptive literature, catalog cuts and specifications with the bid to enable the Lottery to determine if the product offered meets the requirements of the solicitation. U. **RENEGOTIATION OF CONTRACT:**

The Lottery reserves the right, at any time during the Contract term or any renewals of the term, to renegotiate with the Contractor a reduction in the compensation paid to the Contractor that is less than the compensation initially agreed to by the Contractor and the Lottery at the time of Contract execution. The Lottery may initiate such negotiations whenever the Lottery determines that it is in the Lottery's best fiscal interests to do so. Notwithstanding any other provision of this Contract to the contrary, the Lottery may terminate this Contract immediately and without penalty if the Lottery is unable to renegotiate the compensation with the Contractor to an amount which the Lottery determines to be appropriate.

V. **RENEWAL OF CONTRACT:**

This contract may be renewed by the Lottery for three (3) successive one (1) year periods under the terms and conditions of the original Contract except as stated in 1. and 2. below. Price increases/decreases may be negotiated only at the time of renewal. X. **SUBCONTRACTS:**

No portion of the work shall be subcontracted without prior written consent of the Lottery. In the event that the Contractor desires to subcontract some part of the work specified herein, the Contractor shall furnish the Lottery the names, qualifications and experience of their proposed subcontractors. The Contractor shall, however, remain fully liable and responsible for the work to be done by its subcontractor(s) and shall assure compliance with all requirements of the Contract.

Y. **WARRANTY:**

All materials and equipment shall be fully guaranteed against defects in material and workmanship for a period of one (1) year following date of delivery. Should any defect be noted by the Lottery, the Lottery Contract Administrator will notify the Contractor of such defect or non-conformance. If the Contractor is required to correct or replace, it shall be at no cost to the Lottery and shall be subject to all provisions of this clause to the same extent as materials initially delivered.

IV. **GENERAL TERMS AND CONDITIONS:**

A. **ANTI-DISCRIMINATION:**

By submitting their bid, Bidders certify to the Commonwealth that they will conform to the provisions of the Federal Civil Rights Act of 1964, as amended, as well as the Virginia Fair Employment Contracting Act of 1975, as amended, where applicable, the Virginians with Disabilities Act, the Americans with Disabilities Act. If the award is made to a faith-based organization, the organization shall not discriminate against any recipient of goods, services, or disbursements made pursuant to the Contract on the basis of the recipient's religion, religious belief, refusal to participate in a religious practice, or on the basis of race, age, color, gender or national origin and shall be subject to the same rules as other organizations that contract with public bodies to account for the use of the funds provided; however, if the faith-based organization segregates public funds into separate accounts, only the accounts and programs funded with public funds shall be subject to audit by the Virginia Lottery.

In every Contract over \$10,000 the provisions in 1. and 2. below apply:

1. The Contractor will include the provisions of 1. above in every subcontract or purchase order over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.

B. **ADDENDA:**

Any changes or supplemental instructions to this Invitation for Bid shall be in the form of written addenda. Each Bidder is responsible for determining that all addenda issued have been received and shall acknowledge receipt of all addenda in the space provided within the Pricing Schedule or by returning a copy of each signed addendum. Failure to do so may result in rejection of the bid. All addenda so issued shall become part of the IFB and any resulting contract documents.

C. **ANNOUNCEMENT OF AWARD:**

Upon the award or the announcement of the decision to award a Contract over \$50,000, as a result of this solicitation, Lottery will publicly post such notice on the DGS/DPS eVA web site ([www.eva.virginia.gov](http://www.eva.virginia.gov)).

D. **ANTITRUST:**

By entering into a Contract, the Contractor conveys, sells, assigns, and transfers to the Commonwealth of Virginia all rights, title and interest in and to all causes of action it may now have or hereafter acquire under the antitrust laws of the United States and the Commonwealth of Virginia, relating to the particular goods or services purchased or acquired by the Commonwealth of Virginia under said Contract.

E. **APPLICABLE LAWS AND COURTS:**

This solicitation and any resulting Contract shall be governed in all

respects by the laws of the Commonwealth of Virginia, and any litigation with respect thereto shall be brought in the courts of the Commonwealth. The Contractor shall comply with all applicable federal, state and local laws, rules and regulations including Virginia Lottery Law § 58.1-4000 et seq. and the Virginia Lottery Purchasing Manual.

F. **ASSIGNMENT OF CONTRACT:**

A Contract shall not be assignable by the Contractor in whole or in part without the written consent of the Lottery.

G. **AVAILABILITY OF FUNDS:**

It is understood and agreed between the parties herein that the Lottery shall be bound hereunder only to the extent of the funds available or which may hereafter become available for the purpose of this agreement.

H. **BID PRICE CURRENCY:**

Unless stated otherwise in the solicitation, Bidders shall state bid/offer prices in US dollars.

I. **CHANGES TO THE CONTRACT:**

Changes can be made to the Contract in any of the following ways:

1. The parties may agree in writing to modify the scope of the Contract. An increase or decrease in the price of the Contract resulting from such modification shall be agreed to by the parties as a part of their written agreement to modify the scope of the Contract.
2. The Lottery may order changes within the general scope of the Contract at any time by written notice to the Contractor. Changes within the scope of the Contract include, but are not limited to, things such as services to be performed, the method of packing or shipment, and the place of delivery or installation. The Contractor shall comply with the notice upon receipt. The Contractor shall be compensated for any additional costs incurred as the result of such order and shall give the Lottery a credit for any savings. Said compensation shall be determined by one of the following methods:

By mutual agreement between the parties in writing; or

By agreeing upon a unit price or using a unit price set forth in the Contract, if the work to be done can be expressed in units, and the Contractor accounts for the number of units of work performed, subject to the Lottery's right to audit the Contractor's records and/or to determine the correct number of units independently; or

By ordering the Contractor to proceed with the work and keep a record of all costs incurred and savings realized. A markup for overhead and

profit may be allowed if provided by the Contract. The same markup shall be used for determining a decrease in price as the result of savings realized. The Contractor shall present the Lottery with all vouchers and records of expenses incurred and savings realized. The Lottery shall have the right to audit the records of the Contractor as it deems necessary to determine costs or savings. Any claim for an adjustment in price under this provision must be asserted by written notice to the Lottery within 30 days from the date of receipt of the written order from the Lottery. If the parties fail to agree on an amount of adjustment, the question of an increase or decrease in the Contract price or time for performance shall be resolved in accordance with the procedures for resolving disputes provided by the Disputes Clause of this Contract or, if there is none, in accordance with the disputes provisions of the Lottery's Purchasing Manual. Neither the existence of a claim nor a dispute resolution process, litigation or any other provision of this Contract shall excuse the Contractor from promptly complying with the changes ordered by the Lottery or with the performance of the Contract generally.

J. **CLARIFICATION OF TERMS:**

If any prospective Bidder has questions about the specifications or other solicitation documents, the prospective Bidder should contact the buyer whose name appears on the face of the solicitation no later than five (5) working days before the due date. Any revisions to the solicitation will be made only by addendum issued by the buyer.

K. **DEBARMENT STATUS:**

By submitting their bid, Bidders certify that they are not currently debarred by the Commonwealth of Virginia from submitting bids on Contracts for the type of goods and/or services covered by this solicitation, nor are they an agent of any person or entity that is currently so debarred.

L. **DEFAULT:**

In case of failure to deliver goods or services in accordance with the Contract terms and conditions, the Lottery, after due oral or written notice, may procure them from other sources and hold the Contractor responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies which the Lottery may have.

M. **DRUG-FREE WORKPLACE:**

During the performance of this Contract, the Contractor agrees to (i) provide a drug-free workplace for the Contractor's employees; (ii) post in conspicuous places, available to employees and applicants for employment, a statement notifying employees that the unlawful manufacture, sale, distribution, dispensation, possession, or use of a controlled substance or marijuana is prohibited in the Contractor's workplace and specifying the actions that will be taken against

employees for violations of such prohibition; (iii) state in all solicitations or advertisements for employees placed by or on behalf of the Contractor that the Contractor maintains a drug-free workplace; and (iv) include the provisions of the foregoing clauses in every subcontract or purchase order of over \$10,000, so that the provisions will be binding upon each subcontractor or vendor.

For the purposes of this section, “*drug-free workplace*” means a site for the performance of work done in connection with a specific Contract awarded to a Contractor, the employees of whom are prohibited from engaging in the unlawful manufacture, sale, distribution, dispensation, possession or use of any controlled substance or marijuana during the performance of the Contract.

N. **ETHICS IN PUBLIC CONTRACTING:**

By submitting their bid, Bidders certify that their bid are made without collusion or fraud and that they have not offered or received any kickbacks or inducements from any other Bidder, supplier, manufacturer or subcontractor in connection with their bid, and that they have not conferred on any public employee having official responsibility for this procurement transaction any payment, loan, subscription, advance, deposit of money, services or anything of more than nominal value, present or promised, unless consideration of substantially equal or greater value was exchanged.

O. **IMMIGRATION REFORM AND CONTROL ACT OF 1986:**

By entering into a written Contract with the Lottery, the Contractor certifies that they so not, and shall not during the performance of the Contract for goods and services in the Commonwealth, knowingly employ an unauthorized alien as defined in the federal Immigration Reform and Control Act of 1986.

P. **INSURANCE:**

By signing and submitting a bid under this solicitation, the Bidder certifies that if awarded the Contract, it will have the following insurance coverage at the time the Contract is awarded. For construction Contracts, if any subcontractors are involved, the subcontractor will have workers’ compensation insurance in accordance with §§ 2.2-4332 and 65.2-800 et seq. of the *Code of Virginia*. The Bidder further certifies that the Contractor and any subcontractors will maintain this insurance coverage during the entire term of the Contract and that all insurance coverage will be provided by insurance companies authorized to sell insurance in Virginia by the Virginia State Corporation Commission.

**Minimum Insurance Coverages and Limits Required for Most Contracts:**

1. Workers’ Compensation - Statutory requirements and benefits. Coverage is compulsory for employers of three (3) or more employees, to include the employer. Contractors who fail to notify the Commonwealth of increases in the number of

employees that change their workers' compensation requirements under the *Code of Virginia* during the course of the Contract shall be in noncompliance with the Contract.

2. Employer's Liability - \$100,000.
3. Commercial General Liability - \$1,000,000 per occurrence. Commercial General Liability is to include bodily injury and property damage, personal injury and advertising injury, products and completed operations coverage. The Commonwealth of Virginia must be named as an additional insured and so endorsed on the policy.
4. Automobile Liability - \$1,000,000 per occurrence. (Only used if motor vehicle is to be used in the Contract.

**Q. MANDATORY USE OF LOTTERY DOCUMENT:**

Failure to submit a bid on this official Invitation for Bids document shall be a cause for rejection of the bid. Modification of or additions to any portion of the Invitation for Bids may be cause for rejection of the bid; however, the Lottery reserves the right to decide, on a case by case basis, in its sole discretion, whether to reject such a bid as nonresponsive. As a precondition to its acceptance, the Lottery may, in its sole discretion, request that the Bidder withdraw or modify nonresponsive portions of a bid which do not affect quality, quantity, price, or delivery. No modification of or addition to the provisions of the Contract shall be effective unless reduced to writing and signed by the parties.

**R. NONDISCRIMINATION OF CONTRACTOR:**

A Bidder or Contractor shall not be discriminated against in the solicitation or award of this Contract because of race, religion, color, sex, national origin, age, disability, faith-based organizational status, any other basis prohibited by state law relating to discrimination in employment or because the Bidder employs ex-offenders unless the Lottery, department or institution has made a written determination that employing ex-offenders on the specific Contract is not in its best interest. If the award of this Contract is made to a faith-based organization and an individual, who applies for or receives goods, services, or disbursements provided pursuant to this Contract objects to the religious character of the faith-based organization from which the individual receives or would receive the goods, services, or disbursements, the public body shall offer the individual, within a reasonable period of time after the date of his objection, access to equivalent goods, services, or disbursements from an alternative provider.

**S. PAYMENT:**

1. To Prime Contractor:

- a) Invoices for items ordered, delivered and accepted shall be submitted by the Contractor directly to the payment address shown on the purchase order/Contract. All invoices shall show the Lottery Contract number and/or purchase order number; social security number (for individual contractors) or the federal employer identification number (for proprietorships, partnerships, and corporations).
- b) Any payment terms requiring payment in less than 30 days will be regarded as requiring payment 30 days after invoice or delivery, whichever occurs last. This shall not affect offers of discounts for payment in less than 30 days, however.
- c) All goods or services provided under this Contract or purchase order, that are to be paid for with public funds, shall be billed by the Contractor at the Contract price, regardless of which public agency is being billed.
- d) The following shall be deemed to be the date of payment: the date of postmark in all cases where payment is made by mail, or the date of offset when offset proceedings have been instituted as authorized under the Virginia Debt Collection Act.
- e) Unreasonable Charges. Under certain emergency procurements and for most time and material purchases, final job costs cannot be accurately determined at the time orders are placed. In such cases, contractors should be put on notice that final payment in full is contingent on a determination of reasonableness with respect to all invoiced charges. Charges which appear to be unreasonable will be researched and challenged, and that portion of the invoice held in abeyance until a settlement can be reached. Upon determining that invoiced charges are not reasonable, the Lottery shall promptly notify the Contractor, in writing, as to those charges which it considers unreasonable and the basis for the determination. A Contractor may not institute legal action unless a settlement cannot be reached within 30 days of notification. The provisions of this section do not relieve the Lottery of its prompt payment obligations with respect to those charges which are not in dispute.

2. To Subcontractors:

- a) A Contractor awarded a Contract under this solicitation is hereby obligated:
  - i. To pay the subcontractor(s) within seven (7) days of the Contractor's receipt of payment from the

Lottery for the proportionate share of the payment received for work performed by the subcontractor(s) under the Contract; or

ii. To notify the Lottery and the subcontractor(s), in writing, of the Contractor's intention to withhold payment and the reason.

b) The Contractor is obligated to pay the subcontractor(s) interest at the rate of one percent per month (unless otherwise provided under the terms of the Contract) on all amounts owed by the Contractor that remain unpaid seven (7) days following receipt of payment from the Lottery, except for amounts withheld as stated in (2) above. The date of mailing of any payment by U. S. Mail is deemed to be payment to the addressee. These provisions apply to each sub-tier Contractor performing under the primary Contract. A Contractor's obligation to pay an interest charge to a subcontractor may not be construed to be an obligation of the Lottery.

3. The Lottery encourages contractors and subcontractors to accept electronic and credit card payments.

T. **PERSONNEL SECURITY CLEARANCES:**

Section 58.1-4008 of the *Code of Virginia* (Virginia Lottery Law) requires that all Board members, officers and employees of any vendor of lottery online or instant ticket goods or services working directly on a Contract with the Virginia Lottery for such goods or services shall be subject to a criminal background search to be conducted by the chief security officer of the Virginia Lottery. Additionally, Lottery Regulation 5-20-410 extends this to include any parent or Subsidiary Corporation of the vendor, and any shareholder of 5% or more of the vendor, its parent or Subsidiary Corporation.

No person who has been convicted of a felony, bookmaking or other form of illegal gambling, or of a crime involving moral turpitude, shall be employed on Contracts with vendors described in this section.

No Board member, officer, or employee of a vendor to the Virginia Lottery of online or instant ticket goods or services working directly on a Contract for such goods or services, or any person residing in the same household of such Board member, officer or employee, shall purchase a lottery ticket or share, or receive a prize paid on a ticket purchased by or transferred to such person.

U. **PRECEDENCE OF TERMS:**

The following General Terms and Conditions, APPLICABLE LAWS AND COURTS, ANTI-DISCRIMINATION, ETHICS IN PUBLIC CONTRACTING, IMMIGRATION REFORM AND CONTROL ACT OF 1986, DEBARMENT STATUS, ANTITRUST, MANDATORY USE OF STATE FORM AND TERMS

AND CONDITIONS, CLARIFICATION OF TERMS, PAYMENT shall apply in all instances. In the event there is a conflict between any of the other General Terms and Conditions and any Special Terms and Conditions in this solicitation, the Special Terms and Conditions shall apply.

V. **QUALIFICATION OF BIDDER:**

The Lottery may make such reasonable investigations as deemed proper and necessary to determine the ability of the Bidder to perform the services/furnish the goods and the Bidder shall furnish to the Lottery all such information and data for this purpose as may be requested. The Lottery reserves the right to inspect Bidder's physical facilities prior to award to satisfy questions regarding the Bidder's capabilities. The Lottery further reserves the right to reject any bid if the evidence submitted by, or investigations of, such Bidder fails to satisfy the Lottery that such Bidder is properly qualified to carry out the obligations of the Contract and to provide the services and/or furnish the goods contemplated therein.

W. **TAXES:**

Sales to the Commonwealth of Virginia are normally exempt from State sales tax. State sales and use tax certificates of exemption, Form ST-12, will be issued upon request. Deliveries against this Contract shall usually be free of Federal excise and transportation taxes. The Commonwealth's excise tax exemption registration number is 54-73-0076K.

X. **TESTING AND INSPECTION:**

The Lottery reserves the right to conduct any test/inspection it may deem advisable to assure goods and services conform to the specifications.

Y. **TRANSPORTATION AND PACKAGING:**

By submitting their bid, all Bidders certify and warrant that the price offered for FOB destination includes only the actual freight rate costs at the lowest and best rate and is based upon the actual weight of the goods to be shipped. Except as otherwise specified herein, standard commercial packaging, packing and shipping containers shall be used. All shipping containers shall be legibly marked or labeled on the outside with purchase order number, commodity description, and quantity.

Z. **USE OF BRAND NAMES:**

Unless otherwise provided in this solicitation, the name of a certain brand, make or manufacturer does not restrict Bidders to the specific brand, make or manufacturer named, but conveys the general style, type, character, and quality of the article desired. Any article which the public body, in its sole discretion, determines to be the equivalent of that specified, considering quality, workmanship, economy of operation, and suitability for the purpose intended, shall be accepted. The Bidder is responsible to clearly and specifically identify the product being offered



and to provide sufficient descriptive literature, catalog cuts and technical detail to enable the Lottery to determine if the product offered meets the requirements of the solicitation. This is required even if offering the exact brand, make or manufacturer specified. Normally in competitive sealed bidding only the information furnished with the bid will be considered in the evaluation. Failure to furnish adequate data for evaluation purposes may result in declaring a bid nonresponsive. Unless the Bidder clearly indicates in its bid that the product offered is an equivalent product, such bid will be considered to offer the brand name product referenced in the solicitation.
