Sports Book Operator Updates

- VHL VA, LLC (a/k/a 888) Sportsbook closed June 3, 2024. Permit expires November 25, 2024, will not renew.
- Digital Gaming Corporation VA, LLC Sportsbook closed July 31, 2024. Permit expires November 24, 2024, will not renew.
- PlayLive Virginia LLC (d/b/a Superbook) Sportsbook closed July 19, 2024. Permit expires September 28, 2026. **May explore engaging another supplier platform provider.**
- DC Sports Facilities Entertainment, LLC (d/b/a Betfred) Sportsbook closed July 31, 2024. Permit expires 12/14/2025. May explore engaging another supplier platform provider.
- Unibet Interactive Inc.'s permit expired in April 2024.


Q3 CY 2024

Sports Wagering Vendor Renewals:

- 87 renewals YTD.
- 37 have expired, opting not to renew.
- All vendors expiring through Q4 of CY 2024 have been either renewed or provided expiration notification.
 - Renewal notifications for vendors due to expire in Q1 of CY 2025 will be sent by November 1st.
- Failure to renew their registration will result in them not being able to conduct business in the Commonwealth with
 licensed permit holders.

Market Share by Operator


January 2024 to September 2024



Program Enrollment as of October 15, 2024 – 1468 (Active & Inactive)



Exclusion Period Breakdown by Gender


Active enrollments as of October 15, 2024 = 1305 (972 Male (74%); 333 Female (26%)



Voluntary Exclusion Enrollees By Age






Voluntary Exclusion Program

In the Last Quarter


The Lottery approved (2) scheduled projects involving (70) games.

Waiver - Update

Waiver for 11VAC5-90-180.B(3)

- B. Personnel operating and conducting table games
 - 3. A facility operator shall provide a sufficient number of floorpersons to supervise the operation of table games in accordance with the standards in this section, so that a floorperson may not supervise more than the number of tables specified in one of the following:

Caesar's Danville submitted a waiver request for 11VAC5-90-180.B(3) - This was approved.
